THE DRAINAGE AND PLUMBING EXTENSION NOTICE 1944, NO. 3

Department of Health, Wellington, 22nd July, 1944.

PURSUANT to section 133 of the Health Act, 1920, and pursuant to regulations made under that Act on the 3rd day of September, 1923, and to be cited as the Drainage and Plumbing Regulations,* I, Arnold Henry Nordmeyer, Minister of Health, hereby give notice as follows:—

- 1. This notice may be cited as the Drainage and Plumbing Extension Notice 1944, No. 3.
 - 2. This notice shall take effect as from the 1st day of August, 1944.
- 3. The Drainage and Plumbing Regulations* aforesaid are hereby applied to those portions of the County of Coromandel hereinafter described.
- **4.** The Drainage and Plumbing Extension Consolidation Notice 1941† is accordingly amended as follows:—
- (a) Part III of the Second Schedule thereto is amended by inserting therein, preceding the reference to the County of Tauranga under the heading "Thames-Tauranga Health District", the following additional item:—
 - "All those portions of the County of Coromandel described in the items numbered respectively (1) and (2) of Appendix V hereto 1st August, 1944".
- (b) The said Second Schedule is further amended by inserting therein, next following Appendix IV thereof, the following appendix:—

"APPENDIX V

" PARTS OF THE COUNTY OF COROMANDEL

"(1) Whitianga Township Area.—All that area in the Auckland Land District, in the Coromandel County, situated in Blocks VII and X, Otama Survey District, bounded by a line commencing at a point on the northern side of the Coromandel—Mercury Bay Main Highway where it is crossed by the Waitotara Stream; thence running easterly along the northern side of the said highway to the western corner of Part Whakau Block as shown on D.P. 1549; thence northerly generally along the western boundary of the aforesaid Part Whakau Block and a right line from its northern corner to the southern corner of Part Weiti Number 1 Block as shown on D.P. 402; thence along the western boundary of the aforesaid Part Weiti Block and along a right line from its north-western corner across a public road to the south-western corner of another part of the aforesaid Weiti Number 1 Block as shown on D.P. 357; thence along the western boundary of the aforesaid Part Weiti Number 1 Block to its junction with the Taputapuatea Stream; thence along a right line from that junction to the southernmost corner of Section 2, Block VII, Otama Survey District, and along its south-eastern boundary to the northern corner of Part Kuaotunu Number 4B Block; thence southerly and westerly generally along the north-eastern and south-eastern boundaries of that block and along the foreshore of Mercury Bay, Whitianga Harbour, and Waitotara Stream, to the point of commencement.

"(2) Coromandel Township Area.—All that area in the Auckland Land District, in the Coromandel County, bounded, commencing at a point on the foreshore of the Coromandel Harbour, being the production across a public road of the south-eastern boundary of Old Land Claim 32 (Wynyardton Township); thence running north-easterly generally along a right line across that road, and along the said south-east boundary of the said Old Land Claim to the northernmost corner of the Waiwhau Block; thence along the western boundary of that block to and up the Whangarahi Stream and along the northern boundary of Allotment 11, Kapanga Parish; thence in a southerly direction generally along the eastern and southern boundaries of that allotment and the western boundary of Section 33A, Village of Buffalo, and that boundary produced across a road, along the southern side of that road to and along the western boundary of Section 32 of the said village to its southernmost corner; thence by a right line from the said southernmost corner, across Section 3, Block VI, Coromandel Survey District, and Part Karaka Number 1 Block to the north-eastern corner of Kahakaharoa Number 2 Block; thence along the north-east boundary of the said block and by a right line from its south-eastern corner to the intersection of the north-eastern boundary of Allotment I, Kapanga Parish (Kapanga Township), with the Taumatawahine Stream; thence along the aforesaid north-eastern boundary and part of the south-eastern boundary of the said Allotment 1 (Kapanga Township), the south side of a road (James Street), and part of the western side of Te Tiki Road and along the south-eastern boundary of Te Pora and north-eastern boundary of Tore Te Peka Blocks to the Karaka Stream; thence up that stream and the Pitoti (Aitkin) Stream to the north-western boundary of Pukemaukuku Block, D.P. 26043; thence along the north-western boundary of the said block and the north-west and south-west boundaries of Section 6, being a subdivision of the aforesaid Pukemaukuku Block, Deeds Plan H11, to a road or right-of-way; thence along the north-western and south-western side of the said road or right-ofway to the south-eastern corner of Section 1 of the aforesaid Pukemaukuku Block as shown on the said Deeds Plan H11, and along the south-eastern boundary of that section to its southern corner at the Huaroa Stream; thence by a right line from the said corner to the north-eastern corner of Lot 4, Deeds Plan 190, being part of Allotment 3, Kapanga Parish, along the eastern boundary of the said Lot 4 and along the eastern and southern boundaries of Lot 3 on the aforesaid Deeds Plan 190, and along a right line, being the production southward of the western boundary of the said Lot 3 to Emslie Road; thence westerly generally along the north side of that road to and across Tiki Road, along the western side of that road, and along the southern side of Stapleton Road to the north-eastern side of Ponsonby Road; thence in a northerly direction generally along the northeastern side of that road, the north-eastern side of Kingston Road, to and across the Huaroa Road, and along its north-western side to the western boundary of Part Ngorongoro Block, D.P. 1372; thence along the aforesaid western boundary and the southern boundary of Pukekorahi Block to the Huaroa Creek; thence down that creek and along the foreshore of the Coromandel Harbour, to the place of commencement."
