**THE DRAINAGE AND PLUMBING EXTENSION NOTICE 1946,
NO. 2**

Department of Health,
Wellington, 9th September, 1946.

PURSUANT to section 133 of the Health Act, 1920, and pursuant to regulations made under that Act on the 3rd day of September, 1923, and to be cited as the Drainage and Plumbing Regulations,* I, Arnold Henry Nordmeyer, Minister of Health, hereby give notice as follows :—

1. This notice may be cited as the Drainage and Plumbing Extension Notice 1946, No. 2.
2. This notice shall take effect on the 1st day of October, 1946.
3. The Drainage and Plumbing Regulations are hereby applied to that portion of the County of Taumarunui hereinafter described.
4. The Drainage and Plumbing Extension Consolidation Notice 1941† is accordingly amended as follows :—

(a) Part III of the Second Schedule thereto (as heretofore amended) is amended by inserting therein, under the heading "South Auckland Health District", and next following the item "Waipa (the whole county) 15th July, 1941", the following additional item :—

" All that portion of the Taumarunui County described in Appendix VI hereto 1st October, 1946."

(b) The said Second Schedule is further amended by adding thereto, next following Appendix V thereof, the following Appendix :—

" APPENDIX VI

" PARTS OF THE COUNTY OF TAUMARUNUI

" ALL that area in the Auckland Land District in the County of Taumarunui, situated in Block XIII, Tuhua Survey District: bounded by a line commencing at a point on the left bank of the Ongarue River in line with the southern boundary of Section 2A, Block XIII, Tuhua Survey District, and running easterly along a right line across a public road, to and along the said southern boundary to the Taringamutu Road; thence south-easterly along the south-western side of that road to a point in line with the south-eastern side of the public road forming the north-western boundary of Section 16 of the said Block XIII; thence along a right line across Taringamutu Road aforesaid, to and along the south-eastern side of the said road and the generally southern side of the public road forming the northern boundaries generally of the said Section 16, Sections 58, Part 55, another part of 58 aforesaid, Part 3 and 37, all of Block

XIII, Tuhua Survey District aforesaid, and a right line being the production of the said southern side across another public road to the north-western boundary of Section 56, Block XIII aforesaid; thence southerly generally along the south-eastern side of the last-mentioned public road, to and along the south-western boundary of Section 24 of the said Block XIII and a right line being the production south-easterly of the last-mentioned boundary across the Rangaroa Stream to the northern boundary of the Borough of Taumarunui; thence westerly along the said borough boundary, being along the southern side of the Rangaroa Stream, the generally northern boundaries of Sections 8, 7, 6, 5, 4, 2, and 1, Block I, Village of Rangaroa, and again along the southern side of the Rangaroa Stream to the left bank of the Ongarue River; thence northerly up the left bank of the said river to the point of commencement."
