THE DRAINAGE AND PLUMBING EXTENSION NOTICE (NO. 6) 1951

PURSUANT to section 133 of the Health Act 1920, the Minister of Health hereby gives notice as follows :---

1. (1) This notice may be cited as the Drainage and Plumbing Extension Notice (No. 6) 1951.

(2) This notice shall come into force on the 1st day of January 1952.

2. The Drainage and Plumbing Regulations* are hereby applied to those portions of the County of Marlborough hereinafter described.

3. The Drainage and Plumbing Extension Consolidation Notice 1950[†] is hereby accordingly amended by inserting in Part III of the Second Schedule, under the heading "Nelson Health District", and after the reference to the Town District of Havelock (as inserted by clause 4 of the Drainage and Plumbing Extension Notice 1950, No. 2), the following words :--

"All those portions of the County of

Marlborough described in Appendix IX

1 January 1952." hereto 4. The Drainage and Plumbing Extension Consolidation Notice

1950 is hereby further amended by adding the following Appendix :-

"APPENDIX IX

" PARTS OF THE COUNTY OF MARLBOROUGH

"(1) All that area containing by admeasurement 12 acres 0 roods 16.34 perches, being Lots 1 to 36 (inclusive) on D.P. 1910, and being part Sections 2 of 28, and 3 of 28, Omaka Registration District, and Part Section 1, Block III, Taylor Pass Survey District.

"(2) All those areas in Block XV, Cloudy Bay Survey District, containing together by admeasurement 5 acres 2 roods 35-15 perches, being part Section 10, Omaka Registration District, containing 4 acres 1 rood 8.12 perches, and being all the land comprised in limited certificate of title, Volume 48, folio 4, Marlborough Registry; Lot 1 on D.P. 1833, containing 1 acre 34:4 perches; and Lots 1 to 6 (inclusive) on D.P. 1831, containing 1 acre 34:4 perches; the said Lot 1 on D.P. 1833 and the said Lots 1 to 6 on D.P. 1831 being also parts of the aforesaid Section 10, Omaka Registration District."
