DENTAL AMENDMENT REGULATIONS (NO. 2) 1997

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 83 of the Dental Act 1988, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and on the advice of the Minister of Health given after consultation by the Minister with the Dental Council, makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Dental Amendment Regulations (No. 2) 1997, and are part of the Dental Regulations 1988* ("the principal regulations").

(2) These regulations come into force on 1 June 1997.

2. Fees—The principal regulations are amended by revoking Part I of the Schedule (as substituted by regulation 2 of the Dental Regulations 1988, Amendment No. 4), and substituting the new Part I set out in the Schedule of these regulations.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 June 1997, alter certain fees payable to the Dental Council.

The fee payable in respect of an annual practising certificate for a dentist decreases from \$468.00 to \$325.00. The fee payable in respect of an application for registration as a specialist dentist increases from \$56.25 to \$278.00, and the fee payable in respect of a certificate of temporary registration increases from \$90.00 to \$152.00. The other fees remain unchanged.

The fees are inclusive of goods and services tax.
