ORDER IN COUNCIL

PURSUANT to section 40 of the Dairy Board Act 1961, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Dairy Board (Revocation of Bobby Calf Marketing Regulations 1955) Regulations 1989.

(2) Regulation 2 of these regulations shall come into force on the 1st day of July 1989.

(3) The rest of these regulations shall come into force on the 28th day after the date of their notification in the *Gazette*.

2. Revocation of Bobby Calf Marketing Regulations 1955—(1) The following regulations are hereby revoked:

(2) All bobby calf committees and saleyard committees established under the Bobby Calf Marketing Regulations 1939, the Bobby Calf Marketing Regulations 1946, the Bobby Calf Marketing Regulations 1947, or the Bobby Calf Marketing Regulations 1955, are hereby dissolved.

3. Transitional—(1) Every bobby calf committee as aforesaid shall, as soon as is reasonably practicable after receiving any returns from the sale of bobby calves, distribute those returns to the appropriate members.

(2) Subject to subclause (1) of this regulation, every such committee shall, on or before the 30th day of June 1989, transfer all its assets (if any) to Dairy Meats Association (Incorporated).

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations revoke the Bobby Calf Marketing Regulations 1955, and provide for the disposal of the assets of bobby calf committees. Proceeds from sales of calves are to go to the farmers concerned. Any other assets are to go to a newly formed incorporated society called Dairy Meats Association (Incorporated).
