THE DANGEROUS DRUGS AMENDING REGULATIONS 1947, NO. 2

At the Government Buildings at Wellington, this 10th day of December, 1947

Present :

THE RIGHT HON. P. FRASER PRESIDING IN COUNCIL

PURSUANT to the provisions of the Dangerous Drugs Act, 1927, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. These regulations may be cited as the Dangerous Drugs Amending Regulations 1947, No. 2.

2. These regulations shall be read together with and form part of the Dangerous Drugs Regulations 1928* (hereinafter referred to as the principal regulations).

3. These regulations shall come into force on the 23rd day of December, 1947.

4. Clause (7) of Regulation 6 of the principal regulations as enacted by the Dangerous Drugs Amendment Regulations 1934 is amended by revoking paragraph (ii) thereof, and substituting the following paragraph :

"(ii) A register, being a bound book of consecutively numbered pages on the verso pages of which shall be printed Part I of form No. 7 (c) in the First Schedule hereto and on each opposite recto page Part II of the said form No. 7 (c), wherein shall be entered with respect to each dangerous drug and form of dangerous drug purchased, received, produced, manufactured, or otherwise acquired, or sold, distributed, dispensed, administered, used in manufacture, or otherwise disposed of by him the particulars indicated by that form and the matter required by clause (4) of Regulation 6 hereof to be prepared, recorded, and entered. In the case of every shop or place of business in which the business of a pharmaceutical chemist as defined by the Pharmacy Act, 1939, is carried on, this register shall be retained continuously on the premises as a permanent record of the business there carried on."
