THE DANGEROUS DRUGS REGULATIONS 1951, AMENDMENT NO. 2

At the Government House at Wellington this 13th day of February 1957

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Dangerous Drugs Act 1927, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. (1) These regulations may be cited as the Dangerous Drugs Regulations 1951, Amendment No. 2, and shall be read together with and deemed part of the Dangerous Drugs Regulations 1951* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.
- 2. Regulation 19 of the principal regulations is hereby amended by omitting the words "in the form numbered 4", and substituting the words "in form 4 or form 4a".
- 3. (1) Regulation 27 of the principal regulations is hereby amended by revoking subclause (2), and substituting the following subclause:
- "(2) Every licensee to whom this regulation applies shall, unless pursuant to regulation 19 hereof he elects to keep a register in form 4 in the Schedule hereto, keep a Licensee's Register consisting of—

"(a) The prescription book referred to in subclause (3) of this regulation; and

- "(b) A register in accordance with subclause (4) of this regulation."
- (2) The said regulation 27 is hereby further amended by revoking subclause (4), and substituting the following subclauses:
 - "(4) The said register shall be either—
 - "(a) A bound book of consecutively numbered pages in form 4A in the Second Schedule hereto; or

*S.R. 1951/287 Amendment No. 1: S.R. 1955/94 "(b) A bound book of consecutively numbered pages, on the verso pages of which there shall be printed Part I of form 5 in the Second Schedule hereto, and on the recto pages of which there shall be printed Part II of the said form 5.

"(5) In the case of every shop or place of business in which the business of a chemist is carried on, the register kept in accordance with subclause (4) of this regulation shall be retained continuously on the premises as a permanent record of the business carried on there."

4. Regulation 29 of the principal regulations is hereby amended as

follows:

- (a) By omitting from subclause (1) the words "in the form prescribed by regulation 19 hereof", and substituting the words "in form 4 in the Second Schedule hereto":
- (b) By omitting from paragraph (a) of subclause (1) the words "in the form numbered 6", and substituting the words "in form 4A or form 6":
- (c) By omitting from paragraph (b) of subclause (1) the words "in the form numbered 7", and substituting the words "in form 4A or form 7".
- 5. Regulation 30 of the principal regulations is hereby amended by omitting from paragraph (c) the words "The Ward Book shall at all times show on the 'receipts' side entries in the columns numbered (1), (2), and (3) corresponding to the entries in the columns numbered (2), (3), and (4) on the 'issues' side of the Main Register', and substituting the words "The Ward Book shall at all times show entries of receipts corresponding to entries of disposals in the Main Register".

6. Regulation 46 of the principal regulations is hereby amended by

revoking subclause (3).

- 7. Part II of the First Schedule to the principal regulations, as amended by regulation 5 (2) of the Dangerous Drugs Regulations 1951, Amendment No. 1, is hereby further amended by adding the following clauses:
- "31. 1, 3-dimethyl-4-phenyl-4-propionoxyhexamethyleneimine and its salts and any preparation, admixture, extract, or other substance containing any proportion of 1, 3-dimethyl-4-phenyl-4-propionoxyhexamethyleneimine or its salts.

"32. 3-hydroxy-N-phenethylmorphinan and its salts and any preparation, admixture, extract, or other substance containing any proportion of

3-hydroxy-N-phenethylmorphinan or its salts.

"33. 3-diethylamino-1, 1-di(2'-thienyl)-1-butene (diethylthiambutene) and its salts and any preparation, admixture, extract, or other substance containing any proportion of 3-diethylamino-1, 1-di(2'-thienyl)-1-butene or its salts.

"34. 4-morpholino-2, 2-diphenyl ethyl butyrate and its salts and any preparation, admixture, extract, or other substance containing any pro-

portion of 4-morpholino-2, 2-diphenyl ethyl butyrate or its salts.

"35. 4-dimethylamino-1, 2-diphenyl-3-methyl-2-propionoxybutane and its salts and any preparation, admixture, extract, or other substance containing any proportion of 4-dimethylamino-1, 2-diphenyl-3-methyl-2-propionoxybutane or its salts."

8. The Second Schedule to the principal regulations is hereby amended by inserting, after form 4, the new form 4A set out in the Schedule hereto.

9. The Fourth Schedule to the principal regulations, as amended by regulation 7 of the Dangerous Drugs Regulations 1951, Amendment No. 1, is hereby further amended by adding the following clause:

"7. 4-dimethylamino-1, 2-diphenyl-3-methyl-2-propionoxybutane and its salts and any preparation of 4-dimethylamino-1, 2-diphenyl-3-methyl-

2-propionoxybutane or its salts."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Dangerous Drugs Regulations 1951.

Regulations 2, 3, 4, and 8 add a new and alternative form of drug register,

which may be used by all licensees.

Regulation 5 amends the provisions of the principal regulations as to the entries to be made in the Ward Book on receipt of supplies from the hospital store or dispensary.

Regulation 6 brings the principal regulations into line with the Food and Drug Regulations 1946 and the Poisons (General) Regulations 1937 by revoking the provision requiring chemists to report to a Medical Officer of Health any prescriber who defaults in giving prompt written confirmation of prescriptions given orally for dangerous drugs.

Regulation 7 adds the names of certain drugs and preparations to the list of dangerous drugs to which the Dangerous Drugs Act 1927 and the principal

regulations apply.

The effect of regulation 9 is that the preparations mentioned in that regulation are partially exempted from the operation of the regulations, once those drugs are in the hands of chemists, doctors, dentists, veterinary surgeons, hospitals, or approved institutions for the care of the sick or aged.
