THE DANGEROUS DRUGS REGULATIONS 1951, AMENDMENT NO. 4

ORDER IN COUNCIL

At the Government House at Wellington this 24th day of August 1960

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Dangerous Drugs Act 1927, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Dangerous Drugs Regulations 1951, Amendment No. 4, and shall be read together with and deemed part of the Dangerous Drugs Regulations 1951* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. (1) Regulation 62 of the principal regulations is hereby amended by omitting from subclause (4) the words "place or locality", and substituting the words "place, locality, or vehicle".

substituting the words "place, locality, or vehicle". (2) Regulation 62 of the principal regulations is hereby further amended by adding to subclause (4) the following paragraph:

"(d) Also approved in writing by the Director-General."

(3) Regulation 62 of the principal regulations is hereby further amended by adding to paragraph (c) of subclause (4) the word "or".

3. (1) Part II of the First Schedule to the principal regulations, as substituted by regulation 7 of the Dangerous Drugs Regulations 1951, Amendment No. 3, is hereby amended by inserting in Section B, in their appropriate numerical order, the following paragraphs:

"1A. Allylprodine (3-allyl-1-methyl-4-phenyl-4-propionoxypiperidine);

"4A. Benzethidine (1-(2-benzyloxyethyl)-4-phenylpiperidine-4-carboxylic acid ethyl ester);

"12A. Diphenoxylate (1-(3,3-diphenyl-3-cyanopropyl)-4-phenylpiperidine-4-carboxylic acid ethyl ester);

- "15A. Furethidine (1-(2-tetrahydrofurfuryloxyethyl)-4-phenyl-piperidine-4-carboxylic acid ethyl ester);
- "17A. 2'-hydroxy-5,9-dimethyl-2-phenethyl-6,7-benzmorphan, also known as NIH 7519;
- "21A. Levophenacylmorphan ((-)-3-hydroxy-N-phenacylmorphinan);
- (1,2,3,4,5,6-hexahydro-8-hydroxy-3,6,11-trimethyl-"22A. Metazocine 2,6-methano-3-benzazocine);

by inserting in Section C, after paragraph 4, the following paragraph: "4A. Norcodeine (N-demethylated codeine)".

4. (1) The Fourth Schedule to the principal regulations, as substituted by regulation 8 of the Dangerous Drugs Regulations 1951, Amendment No. 3, is hereby amended by inserting, after the heading, the words "The following substances, their salts:".

(2) The Fourth Schedule to the principal regulations is hereby further amended by inserting, after paragraph 4, the following paragraph:

"4A. Norcodeine (N-demethylated codeine).".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Dangerous Drugs Regulations 1951.

Regulation 2 allows the Director-General of Health to approve places, localities, or vehicles in which ampoule syringes containing dangerous drugs may be kept in first-aid kits.

Regulation 3 names a number of new substances which are declared to be dangerous drugs.

Regulation 4 corrects an omission and adds the salts of Norcodeine (N-demethylated codeine), which are named in regulation 3, to the Schedule of partially exempted substances.
