THE DAIRY-PRODUCE EXPORT PRICES ORDER, 1936, AMENDMENT NO. 1.

Enacting authority: His Excellency the Governor-General in Council.

Act pursuant to which the regulations were made: Section 20 of the Primary Products Marketing Act, 1936.

Date on which the regulations were made: 4th day of November, 1936.

Date of notification in Gazette: 12th day of November, 1936.

ORDER.

1. This Order may be cited as the Dairy-produce Export Prices Order, 1936, Amendment No. 1, and shall be read together with and be deemed to be part of the Dairy-produce Export Prices Order, 1936* (hereinafter referred to as "the principal Order").

2. Clause 5 of the principal Order is revoked, and the following clause substituted :---

"5. The appropriate price payable by the Crown pursuant to clause 3 hereof in respect of any butter to which that clause applies is hereby varied as follows:—

- "(a) By payment for each box of butter packed in the Saranac wire-bound box of the type prescribed by the dairy regulations, the thickness of timber of which is less than $\frac{3}{8}$ in., at the rate of threepence per box less than the appropriate price payable for butter packed in any other export butter-box of a type prescribed by the dairy regulations:
- "(b) By payment for each box of salted butter wrapped as described in paragraph (d) hereof and packed in a box of the type prescribed in paragraph (a) hereof at the rate of one penny three-farthings per box more than the appropriate price payable for butter not so wrapped:
- "(c) By payment of the further sum of one farthing per pound in respect of unsalted butter which is manufactured by any manufacturer at the request in writing of the Department, and in such quantity as is from time to time specified in any such request, and which is properly wrapped with vegetable parchment paper of the quality and kind prescribed by the dairy regulations:

"(d) By payment of the further sum of nine thirty-seconds of a penny per pound in respect of unsalted butter which is manufactured as aforesaid and which is properly wrapped with two thicknesses of vegetable parchment paper of the quality prescribed by the dairy regulations but weighing not less than seventeen pounds per ream and having between the two sheets of such paper aluminium foil of not less than 0.009 in. gauge, the paper and foil to be closely bonded together with a suitable wax adhesive.

"Provided, first, that the price of any salted butter may be varied both under paragraph (a) and under paragraph (b) of this clause; secondly, that the price of any unsalted butter may be varied both under paragraph (a) and under paragraph (c) or paragraph (d) of this clause, but if varied under paragraph (c) or paragraph (d) shall not be varied under the other of those paragraphs."
