THE DAIRY FACTORY MANAGERS REGULATIONS 1941, AMENDMENT NO. 1

At the Government House at Wellington, this 4th day of February, 1948

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Dairy Industry Act, 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Dairy Factory Managers Regulations 1941, Amendment No. 1, and shall be read together with and deemed to form part of the Dairy Factory Managers Regulations 1941* (hereinafter called the principal regulations).
- 2. These regulations shall come into force on the seventh day following notification in the *Gazette* of the making thereof.
 - 3. Regulation 3:2 of the principal regulations is amended—
 - (a) By revoking the word "eight," and substituting the word "nine":
 - (b) By inserting, next after paragraph (e), the following paragraph:—
 - "(f) one person, who shall be the holder of a certificate issued and for the time being in force under these regulations, on the recommendation of the New Zealand Dairy Factories' Employees' Union."
- 4. The person appointed next after the coming into force of these regulations to be a member of the Board on the recommendation of the New Zealand Dairy Factories' Employees' Union shall, subject to the provisions of the principal regulations, hold office until the expiry in the year 1950 of the term of office of the member appointed on the recommendation of the Otago and Southland Cheese-factory Managers' Union.

5. Regulation 3:9 of the principal regulations is amended by

adding thereto the following proviso:-

"Provided that unless his office is sooner vacated every member of the Board shall continue in office until his successor comes into office, notwithstanding that the term for which he was appointed may have expired."

6. Regulation 7:1 of the principal regulations is amended by revoking the word "May" wherever that word occurs, and substituting

the word "April".

- 7. Regulation 8:7 of the principal regulations is amended by revoking the word "May" where that word occurs, and substituting in each case the word "April".
- 8. Regulation 8:8 of the principal regulations is amended by revoking the word "May", and substituting the word "April".

9. Regulations 12:1 to 12:8 (both inclusive) of the principal regulations are revoked, and the following regulations substituted:—

"12:1. The Travelling-allowance Regulations 1941* (hereinafter in this Part of these regulations referred to as the said regulations) shall apply to and be deemed to be incorporated in these regulations so as to relate to the Board and its members.

"12:2. The subsistence allowance referred to in Regulation 4 of the said regulations shall be after the rate of £1 7s. 6d. per day.

"12:3. The mileage-allowance referred to in Regulation 11 of the said regulations for journeys performed in a motor-vehicle shall be computed according to the horse-power of the vehicle on R.A.C. rating after the following, namely—

"(a) Where the horse-power of the vehicle does not exceed $9\frac{1}{2}$, $5\frac{1}{2}$ d. a mile:

- "(b) Where the horse-power of the vehicle exceeds 9½ but does not exceed 14½, 6¼d. a mile:
- "(c) Where the horse-power of the vehicle exceeds $14\frac{1}{2}$, $6\frac{3}{4}$ d. a mile.
- "12:4. The amount payable in respect of actual garage expenses referred to in Regulation 11 of the said regulations shall not exceed 2s. 6d. for every night."
- 10. Regulation 12:11 of the principal regulations is amended by revoking the first proviso thereto, and substituting the following proviso therefor:—
- "Provided that where any such person uses his own private motor-vehicle in travelling on the business of an examiner or supervisor there may be paid to such person as locomotion expenses a mileage-allowance at the appropriate rate prescribed by Regulation 12:3 hereof."
- 11. The form numbered 4 in the Second Schedule to the principal regulations is amended by deleting the word "May" where it appears in the footnote, and substituting the word "April".
