**THE DAIRY FACTORY MANAGERS REGULATIONS 1941,  
AMENDMENT NO. 12**

**ORDER IN COUNCIL**

At the Government Buildings at Wellington this 21st day of June 1976

Present:

THE HON. J. B. GORDON PRESIDING IN COUNCIL

PURSUANT to the Dairy Industry Act 1952, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

**REGULATIONS**

**1. Title and commencement**—(1) These regulations may be cited as the Dairy Factory Managers Regulations 1941, Amendment No. 12, and shall be read together with and deemed part of the Dairy Factory Managers Regulations 1941\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of August 1976.

**2. Fees**—(1) Regulation 11 of the principal regulations is hereby amended by revoking subclause (1) (as amended by regulation 8 of the Dairy Factory Managers Regulations 1941, Amendment No. 2†), and substituting the following subclause:

“(1) The fees payable under these regulations shall be those set out in the Third Schedule to these regulations.”

(2) Regulation 8 of the Dairy Factory Managers Regulations 1941, Amendment No. 2, is hereby consequentially revoked.

**3. Schedule**—The principal regulations are hereby further amended by adding, as a Third Schedule, the Schedule set out in the Schedule to these regulations.

## EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations increase various fees payable under the principal regulations. The fee for an application for registration and an application for the renewal of a certificate of registration is increased from \$1 to \$5. The fee for a duplicate certificate is increased from 50c to \$2.50. The fee for a copy of the entries in the register in respect of one name, and a certificate that there are no such entries in respect of a name is increased from 25c to 50c. The fee for a notice of appeal remains unaltered.
