THE HON. S. G. HOLLAND PRESIDING IN COUNCIL

PURSUANT to the Dairy Industry Act, 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Dairy Factory Managers Regulations 1941, Amendment No. 3, and shall be read together with and deemed part of the Dairy Factory Managers Regulations 1941* (hereinafter called the principal regulations).
- 2. Regulations 12:1 to 12:4 of the principal regulations, as set out in Regulation 9 of the Dairy Factory Managers Regulations 1941, Amendment No. 1, are hereby revoked, and the following regulations substituted therefor:—
- "12:1. The Travelling-allowance Regulations 1949† shall apply to and be deemed to be incorporated in these regulations so as to relate to the Board and its members.
- "12:2. The subsistence allowance referred to in Regulation 5 of the Travelling-allowance Regulations 1949 shall be at the rate of £1 15s. a day:
- "Provided that where a member is entitled to a subsistence allowance and occupies a hotel room for one night only, an additional amount of 2s. may be paid to that member.
- "12:3. The mileage allowance referred to in Regulation 13 of the Travelling-allowance Regulations 1949 shall be calculated in accordance with the following table:—

Horse-power of Car.	Mileage Allowance.
Not exceeding $9\frac{1}{2}$ Exceeding $9\frac{1}{2}$ but not exceeding $14\frac{1}{2}$ Over $14\frac{1}{2}$	 $5\frac{1}{2}$ d. a mile. $6\frac{1}{4}$ d. a mile. 7d. a mile

- "12:4. Garage expenses payable to a member pursuant to this regulation shall not exceed 2s. 6d. for every night on which any such expenses are incurred."
- 3. Regulation 9 of the Dairy Factory Managers Regulations 1941, Amendment No. 1, is hereby revoked.
