THE DAIRY FACTORY MANAGERS REGULATIONS 1941, AMENDMENT NO. 7

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL

PURSUANT to the Dairy Industry Act 1952, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Dairy Factory Managers Regulations 1941, Amendment No. 7, and shall be read together with and deemed part of the Dairy Factory Managers Regulations 1941* (hereinafter referred to as the principal regulations).
- 2. (1) Regulation 6:4 of the principal regulations (as amended by regulation 6 of the Dairy Factory Managers Regulations 1941, Amendment No. 2) is hereby further amended by adding the following paragraph:
 - "(f) He must be the holder of a certificate of competency as a second class engine driver under the Boilers, Lifts, and Cranes Act 1950."
- (2) This regulation shall come into force on the 1st day of August 1958.

3. Regulation 6:5 of the principal regulations (as amended by regulation 7 of the Dairy Factory Managers Regulations 1941, Amendment No. 2) is hereby further amended by adding the following paragraph:

"(e) Notwithstanding the provisions of paragraph (a) of this regulation, any applicant for registration as a dairy factory manager with a first class butter certificate or with a first class cheese certificate who produces evidence of having been actively engaged in the performance of practical work in premises registered as a manufacturing dairy (other than a creamery or a cheese factory) or a milk treatment house may, at the discretion of the Board, be credited with the period of that employment or such portion thereof as the Board in its discretion thinks fit, towards the one hundred and twenty weeks required under paragraph (a) of this regulation:

'Provided that:

- "(i) The period credited as aforesaid shall not exceed fifty weeks;
- "(ii) No such period shall be credited unless the applicant has worked in a creamery, where the application is for a butter certificate, or in a cheese factory, where the application is for a cheese certificate, for two periods of not less than thirty weeks during a period beginning on the 1st day of August in one year and ending on the 31st day of May in the following year; and

"(iii) No period shall be credited as aforesaid if the employment to which the application relates is for a period of less than twelve continuous weeks in the same place of employment."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

The regulations require applicants for registration as managers of dairy factories to hold a second class engine driver's certificate.

They also enable the Board, in its discretion, to allow service in manufacturing dairies, other than creameries or cheese factories, and in milk treatment houses towards the minimum total service required by the principal regulations.
