ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Dairy Industry Act 1952, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Dairy Factory Managers Regulations 1979, Amendment No. 4, and shall be read together with and deemed part of the Dairy Factory Managers Regulations 1979\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of August 1987.

**2. Fees**—The principal regulations are hereby amended by revoking the Third Schedule (as substituted by regulation 2 of the Dairy Factory Managers Regulations 1979, Amendment No. 3), and substituting the Third Schedule set out in the Schedule to these regulations.

## EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 1 August 1987, increase the fees payable under the Dairy Factory Managers Regulations 1979.

The fee payable on an application for registration, and the fee payable on an application for renewal of registration, are increased in each case from \$31.40 to \$36.00. The fee payable on a notice of appeal, and the fee payable on an application for the issue of a duplicate certificate of registration, are increased in each case from \$14.80 to \$17.00.
