**THE DAIRY FACTORY SUPPLY REGULATIONS 1936,
AMENDMENT NO. 2**

ORDER IN COUNCIL

At the Government Buildings at Wellington, this 20th day of

Present :

THE RIGHT HON. W. NASH PRESIDING IN COUNCIL

PURSUANT to the Agriculture (Emergency Powers) Act, 1934, and for the purpose of giving effect to certain recommendations of the Commission of Inquiry referred to in the Preamble to that Act, and generally for the purpose of securing the effective conduct of the dairy industry, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Dairy Factory Supply Regulations 1936, Amendment No. 2, and shall be read together with and deemed part of the Dairy Factory Supply Regulations 1936* (hereinafter called the principal regulations).

(2) These regulations shall come into force on the seventh day following notification in the *Gazette* of the making thereof.

2. Clause 1 of the principal regulations is hereby amended by revoking the definition of the term "Commission" in subclause (3) thereof, and substituting the following definition:—

" 'Board' means the New Zealand Dairy Board."

3. The principal regulations are amended by revoking the word "Commission" wherever that word occurs in clauses 2, 5, 6, 7, 8, 9, 10, 11, 11A (as inserted by Regulation 4 of the Dairy Factory Supply Regulations 1936, Amendment No. 1), 12, 14, 15, and 16 of the principal regulations, and substituting in each instance the word "Board."

4. Clause 17 of the principal regulations is hereby revoked, and the following clause substituted:—

" 17. The Board in any inquiry that it undertakes in pursuance of these regulations may, if it thinks fit, associate with it in an advisory capacity the Director or, with his approval, any other officer of the Dairy Division of the Department of Agriculture."

5. Clause 18 of the principal regulations is hereby revoked, and the following clause substituted :—

“ 18. Any order, determination, instruction, or direction made or given by the Board pursuant to these regulations shall be sufficient if made or given in writing signed by the Chairman or Deputy Chairman, and any consent or notice given by the Board under these regulations shall be sufficient if given in writing signed by the Chairman, Deputy Chairman, or any other member or officer of the Board duly authorized in that behalf by the Board.”

6. Clause 20 of the principal regulations is hereby amended by revoking the words “ to a penalty of £5,” and substituting the following words : “ to the penalty prescribed by section 3 of the Agriculture (Emergency Powers) Amendment Act, 1936.”
