# THE DANGEROUS GOODS (LICENSING AUTHORITIES) REGULATIONS 1958, AMENDMENT NO. 10

ORDER IN COUNCIL

At the Government House at Wellington this 17th day of March 1969

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Dangerous Goods Act 1957, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

# REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Dangerous Goods (Licensing Authorities) Regulations 1958, Amendment No. 10, and shall be read together with and deemed part of the Dangerous Goods (Licensing Authorities) Regulations 1958\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of April 1969.

2. Districts in which principal regulations are in force—(1) The First Schedule to the principal regulations is hereby amended by omitting so much of Part I as relates to county councils, and substituting the following words:

(2) The First Schedule to the principal regulations is hereby further amended—

(a) By inserting in that part of Part I that relates to city councils, after the word "Invercargill", the word "Manukau":

- (b) By omitting from that part of Part I that relates to borough councils the words "Hampden", "Manurewa", "Palmerston", "Shannon", "Taradale", and "Waikouaiti":
- (c) By omitting from that part of Part I that relates to town councils the words "Leeston", "Lumsden", "Mangaweka", "Mercer", "Nightcaps", "Outram", and "Southbridge".

(3) The regulations specified in the Schedule to these regulations are hereby revoked.

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

The effect of these regulations is that, in addition to the counties already specified in the principal regulations, those regulations will have effect as bylaws in the counties of Matamata, Taranaki, Waikato, and Waitemata.

The regulations also include the Manukau City Council in the list of city councils (replacing the reference to the Manukau County Council), and omit the names of those local authorities whose districts have been merged in other districts.
