THE RIGHT HON. W. E. ROWLING PRESIDING IN COUNCIL

PURSUANT to section 23 of the Dangerous Goods Act 1957, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Dangerous Goods (Licensing Authorities) Regulations 1958, Amendment No. 17, and shall be read together with and deemed part of the Dangerous Goods (Licensing Authorities) Regulations 1958* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 31st day of March 1975.

2. Districts in which principal regulations are in force—The First Schedule to the principal regulations is hereby amended—

- (a) By inserting in that portion of Part I that relates to County Councils (as substituted by regulation 2 of the Dangerous Goods (Licensing Authorities) Regulations 1958, Amendment No. 10), in its appropriate alphabetical order, the word “Rodney”;
- (b) By omitting from the same portion of Part I the word “Waitemata”.

EXPLANATORY NOTE

The effect of these regulations is that the principal regulations will have effect as bylaws in Rodney County. The name of Waitemata County, which no longer exists as such, has been removed from the list of counties within which the principal regulations apply as bylaws.
