**THE DAIRY-PRODUCE GENERAL REGULATIONS, 1933,
AMENDMENT NO. 5.**

Enacting authority : His Excellency the Governor-General in Council.
Act pursuant to which the regulations were made : The Dairy
Industry Act, 1908.

Date on which the regulations were made : 9th day of December, 1936.
Date of notification in *Gazette* : 17th day of December, 1936.

REGULATIONS.

1. (1) These regulations may be cited as the Dairy-produce General Regulations, 1933, Amendment No. 5.

(2) These regulations shall be read together with and deemed to form part of the Dairy-produce General Regulations, 1933* (hereinafter referred to as "the principal regulations"), as amended by the Dairy-produce General Regulations, 1933, Amendment No. 1; the Dairy-produce General Regulations, 1933, Amendment No. 2; the Dairy-produce General Regulations, 1933, Amendment No. 3 (hereinafter referred to as "Amendment No. 3"); and the Dairy-produce General Regulations, 1933, Amendment No. 4 (hereinafter referred to as "Amendment No. 4").

(3) These regulations shall come into force on the 21st day of December, 1936.

2. Clause 73 of the principal regulations is amended by adding thereto the following additional subclause :—

"(4) On and after the 1st day of February, 1937, no person, whether as principal or agent, shall pack for export beyond New Zealand or export beyond New Zealand any butter in a Saranac wire-bound box, the thickness of timber of which is less than $\frac{3}{8}$ in. unless such butter is wrapped as described in paragraph (b) of subclause (2) of clause 79 hereof."

3. Clause 77 of the principal regulations (as amended by clause 20 of Amendment No. 3 and by clause 15 of Amendment No. 4) is further amended by revoking paragraph (d) thereof, and substituting the following paragraph:—

“(d) The ends, sides, top, and bottom of the box shall consist of single pieces of timber. For the purposes of this paragraph two-piece boards or three-piece boards matched and closely jointed with a dust-proof joint shall be regarded as single pieces provided that—

“(i) No piece shall have a face width at either end of less than 3 in.:

“(ii) No two-piece board shall be used for the ends:

“(iii) No three-piece board shall be used except for the bottom:

“(iv) When a three-piece board is used for the bottom each piece shall have not less than two staples driven astride each wire-binding on the box:

“(v) When two-piece boards are used for more than one of the four boards comprising the sides, top, and bottom, or when a three-piece board is used for the bottom and two-piece boards are used for more than one of the other boards comprising the sides and top, the box shall be so assembled that no two of the narrower pieces comprising such two-piece or three-piece boards are contiguous at the corners of the box.”

4. Clause 79 of the principal regulations (as revoked and replaced by clause 16 of Amendment No. 4) is amended by revoking the figures and words “0.009 inch gauge” in paragraph (b) of subclause (2) thereof, and substituting the figures and words “0.009 millimetres in thickness”.
