ORDER IN COUNCIL

At Wellington this 21st day of January 1991

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Dairy Industry Act 1952 and the Agriculture (Emergency Powers) Act 1934, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Dairy Industry (Revocation of Regulations) Regulations 1991.

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. Revocations—The regulations specified in the Schedule to these regulations are hereby revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations revoke certain regulations relating to the dairy industry.

An earlier revocation of those regulations was effected by the Dairy Industry (Revocation of Regulations) Regulations 1990 (S.R. 1990/288), which lapsed at the close of the session of Parliament that ended on 18 January 1991.
