### THE DELIVERY EMERGENCY REGULATIONS 1940.

# GALWAY, Governor-General. ORDER IN COUNCIL.

At the Government House at Wellington, this 8th day of August, 1940.

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

Pursuant to the Emergency Regulations Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

## REGULATIONS.

- 1. These regulations may be cited as the Delivery Emergency Regulations 1940.
  - 2. In these regulations, unless the context otherwise requires,—
    - "Commodity" includes meat, bread, milk, coal, firewood, groceries, or any other goods described by the Minister as a commodity for the purpose of these regulations by notice in the Gazette:
    - "District" means a locality for which a scheme is prepared or approved under these regulations:
    - "Vendor" means any person who delivers a commodity otherwise than by sale over the counter:
    - "Minister" means the Minister of Supply.
- **3.** (1) Where any association or body of vendors submits to the Minister a scheme for regulating the delivery of any commodity in any district, so as to eliminate so far as may be desirable in the public interest any unnecessary overlapping in such delivery, and the Minister is satisfied that all the vendors of that commodity in the district are parties to the scheme or have been given an opportunity of becoming parties thereto, the Minister may, by notice in the *Gazette*, approve the scheme, either unconditionally or upon or subject to such conditions as he thinks fit.
- (2) Every notice under this regulation shall come into force on a date to be specified in that behalf in the notice, and shall specify the names and addresses of the vendors who are parties to the scheme.

- (3) Any notice under this regulation may be at any time amended or revoked by the Minister by a subsequent notice in the *Gazette*, and any such conditions may from time to time be varied, revoked, or added to by the Minister as he thinks fit.
- 4. (1) While any notice approving a scheme for a commodity in any district is in force under these regulations no person shall, except as provided in the scheme, whether as principal, agent, or otherwise, and whether by motor-vehicle or otherwise, deliver that commodity in the district (otherwise than by sale over the counter) in pursuance of a contract of sale, whether made within the district or elsewhere, unless he is a vendor who is a party to the scheme and his name and address are specified in that behalf in the notice approving the scheme or in an amendment thereof for the time being in force.
- (2) Nothing in this regulation shall relieve any person from the obligation of complying with the provisions of any Act or of any other regulations.

(3) Every person who commits an offence against this regulation shall be liable for every such offence to a fine not exceeding £10.
