THE DAIRY PRODUCE EXPORT CONTAINERS REGULATIONS 1950, AMENDMENT NO. 1

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Agriculture (Emergency Powers) Act 1934, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Dairy Produce Export Containers Regulations 1950, Amendment No. 1, and shall be read together with and deemed part of the Dairy Produce Export Containers Regulations 1950* (hereinafter referred to as the principal regulations).
- 2. The principal regulations are hereby amended by inserting, after regulation 20, the following regulation:—
- "20A. (1) Notwithstanding anything in the last preceding regulation, the Board may in any season, with the concurrence of the Commission and without complying with that regulation, fix and notify delivered prices for butter boxes and cheese crates, taking into account the prices fixed for those containers in respect of the season then last past.
- "(2) Where the Board fixes and notifies delivered prices for butter boxes and cheese crates under subclause (1) of this regulation, the amount of any surplus, ascertained under paragraph (b) of subclause (1) of regulation 20 hereof, resulting from the prices so fixed for those containers may be paid by the Board to the Commission to the credit of the Dairy Industry Account, and the amount of any deficiency so ascertained as aforesaid may be paid by the Commission to the Board out of that account."
- 3. The principal regulations are hereby further amended by inserting, after regulation 25, the following regulation:—
- "25A. It shall be lawful for the Board to purchase fibre board or any other substance which in the opinion of the Board is suitable for use in the manufacture of butter boxes, and to arrange with licenseesfor its manufacture into butter boxes in New Zealand."

EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.

Clause 2 of these regulations provides an alternative procedure for the fixing by the New Zealand Dairy Board of the prices to be paid by dairy companies for butter boxes and cheese crates.

Clause 3 authorizes the Board to purchase fibre board or other suitable material for the making of butter boxes.
