

THE DAIRY PRODUCE EXPORT CONTAINERS REGULATIONS 1950, AMENDMENT NO. 3

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL

PURSUANT to the Agriculture (Emergency Powers) Act 1934, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. (1) These regulations may be cited as the Dairy Produce Export Containers Regulations 1950, Amendment No. 3, and shall be read together with and deemed part of the Dairy Produce Export Containers Regulations 1950* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the seventh day after the date of their notification in the *Gazette*.
- 2. Regulation 2 of the principal regulations is hereby amended as follows:
 - (a) By inserting, after the definition of the term "butter boxes", the following definition:

"Casein container" means any container, other than a container consisting of a corn sack and bacon cloth liner, in which casein may be packed for export and exported":

 (b) By inserting, after the words "cheese crates" in the definition of the term "containers", the words "casein containers":
- (c) By inserting, after the words "whey butter factory" in the definition of the term "manufacturing dairy", the words "casein factory".
- 3. Regulation 6 of the principal regulations is hereby amended by inserting, after the word "cheese" wherever that word appears, the word "casein".

- 4. Subclause (1) of regulation 7 of the principal regulations is hereby amended as follows:
 - (a) By inserting, after the word "cheese" wherever that word appears, the word "casein";
 - (b) By inserting, after the words "cheese crates", the words "casein
- 5. Regulation 8 of the principal regulations is hereby amended by inserting, after the words "cheese crates" wherever those words appear, the words "casein containers".
- 6. Regulation 19 of the principal regulations is hereby amended by inserting, after the words "cheese crates", the words "a delivered price for casein containers".
- 7. Subclause (1) of regulation 20 of the principal regulations is hereby amended by inserting, after the words "cheese crates" wherever those words appear, the words "casein containers".
- 8. Regulation 21 of the principal regulations is hereby amended by inserting, after the word "cheese", the word "casein".
- 9. Regulation 23 of the principal regulations is hereby amended by inserting, after the words "cheese crates" wherever those words appear, the words "casein containers".
- 10. Subclause (1) of regulation 26 of the principal regulations is hereby amended by inserting, after the word "cheese", the word "casein".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

The effect of these regulations is to empower the New Zealand Dairy Board to purchase, as agent for proprietors of manufacturing dairies, casein containers (other than containers consisting of a corn sack and bacon cloth liner) in the same way as the Board now purchases other containers for dairy produce.
