

DISABLED PERSONS EMPLOYMENT PROMOTION ORDER 1997

ORDER IN COUNCIL

At Wellington this 3rd day of November 1997

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to section 4 of the Disabled Persons Employment Promotion Act 1960, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, on the recommendation of the Minister of Employment (made after consultation with the unions, associations, and organisations referred to in section 5 of that Act) makes the following order.

ORDER

- 1. Title and commencement—(1) This order may be cited as the Disabled Persons Employment Promotion Order 1997.
- (2) This order comes into force on the 28th day after the date of its notification in the Gazette.
 - 2. Interpretation—In this order—
 - (a) "The principal Act" means the Disabled Persons Employment Promotion Act 1960; and
 - (b) Terms defined in section 2 of the principal Act have the meanings given to them by that section.
- **3. Exemptions**—(1) Each organisation named in the first column of the Schedule is granted exemption, in respect of every sheltered workshop operated by that organisation specified opposite its name in the second

column of the Schedule, from all provisions of the Minimum Wage Act 1983 and from all provisions of the Holidays Act 1981.

- (2) No exemption granted by subclause (1) is limited or affected by any change of the name of the organisation to which it relates.
- **4. Exemption not to apply to certain employees**—(1) No exemption of any organisation granted by clause 3 (1) applies to the employment, or remuneration for employment, of any person employed by the organisation under an employment contract entered into before the day on which this order was made, unless at the close of the day before that day an exemption under section 4 of the principal Act applied to the person's employment by the organisation.
- (2) No exemption of any organisation granted by clause 3 (1) applies to the employment, or remuneration for employment, of any person employed by the organisation, under an employment contract entered into on or after the day on which this order was made, to provide administrative, advisory, liaison, managerial, supervisory, technical, or other similar services—
 - (a) For or in respect of other employees of the organisation; or
 - (b) For clients of the organisation.
- **5. Condition**—Every exemption granted under clause 3 (1) in respect of a sheltered workshop is granted subject to the condition that it will lapse if—
 - (a) The organisation to which it was granted ceases to be approved by the Minister under section 3 of the principal Act; or
 - (b) The sheltered workshop—
 - (i) Ceases to be owned or controlled by that organisation; or
 - (ii) Ceases to be a sheltered workshop.
- **6. Consequential amendments**—The Disabled Persons Employment Promotion Order 1996 is amended by omitting from Part B of the Schedule—
 - (a) The item relating to South Waikato Achievement Trust Incorporated; and
 - (b) The item relating to Disability Training Services H. B. Incorporated.
- 7. Revocations—Every order under section 4 of the principal Act
 - (a) Was made before the commencement of the Disabled Persons Employment Promotion Order 1996; and
 - (b) Granted an exemption to an organisation that is named in the first column of the Schedule (whatever its name was when the exemption was granted) or was the predecessor of an organisation named in that column; and
- (c) Was in force immediately before the commencement of this order,—is revoked.
