PURSUANT to the Domestic Proceedings Act 1968, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Domestic Proceedings (Marriage Guidance Organisations) Order 1979.

(2) This order shall come into force on the day after the date of its notification in the *Gazette*.

2. Approved marriage guidance organisations—The organisations specified in the First Schedule to this order are hereby approved for the purposes of Part II of the Domestic Proceedings Act 1968.

3. Revocations—The orders specified in the Second Schedule to this order are hereby revoked.
