**THE DAIRY PRODUCE REGULATIONS 1938,
AMENDMENT NO. 10**

ORDER IN COUNCIL

At the Government House at Wellington, this 28th day of July 1954

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Dairy Industry Act 1952, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Dairy Produce Regulations 1938, Amendment No. 10, and shall be read together with and deemed part of the Dairy Produce Regulations 1938* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of August 1954.

2. Subclause (1) of regulation 2 of the principal regulations is hereby amended as follows:

(a) By repealing the definition of the term "cheese factory", and substituting the following definition:

" 'Cheese factory' means a manufacturing dairy used or intended to be used for the manufacture of whole milk cheese ":

(b) By adding the following definitions:

" '52% fat cheese' means cheese manufactured from whole milk with cream added, or from a mixture of whole milk and skimmed milk, and containing not less than 52 per cent of milk fat in the dry matter:

" 'Whole milk cheese' means cheese manufactured from whole milk from which no fat has been removed."

3. (1) Regulation 7 of the principal regulations is hereby amended as follows:

- (a) By omitting from paragraph (b) of subclause (2) the words "full cream cheese", as substituted by paragraph (a) of regulation 6 of the Dairy Produce Regulations 1938, Amendment No. 4, and substituting the words "whole milk cheese":
- (b) By omitting from paragraph (d) of subclause (4) the words "the manufacture of full cream cheese from whole milk", and substituting the words "the manufacture of whole milk cheese".

(2) Paragraph (a) of regulation 6 of the Dairy Produce Regulations 1938, Amendment No. 4, is hereby revoked.

4. Subclause (1A) of regulation 18 of the principal regulations, as inserted by regulation 6 of the Dairy Produce Regulations 1938, Amendment No. 8, is hereby amended as follows:

- (a) By omitting from paragraph (a) the words " $\frac{1}{2}$ d. per pound", and substituting the words "1d. per pound":
- (b) By omitting from paragraph (b) the words "0.2d. per pound", and substituting the words "0.4d. per pound".

5. Regulation 25 of the principal regulations, as amended by regulation 12 of the Dairy Produce Regulations 1938, Amendment No. 4, is hereby further amended as follows:

- (a) By omitting the words "full cream cheese" wherever they occur in subclause (1), and substituting in each case the words "whole milk cheese":
- (b) By revoking paragraph (a) of subclause (1), and substituting the following paragraph:
 - "(a) A general brand of the design set out in the form numbered 6 in the Second Schedule hereto":
- (c) By omitting from paragraph (b) of subclause (1) the words "forms numbered 6 and 6A", and substituting the words "form numbered 6":
- (d) By omitting from the proviso to subclause (2) the words "full cream cheese", and substituting the words "whole milk cheese":
- (e) By omitting from the proviso to subclause (2) the words "8, 10, and 10A", and substituting the words "8 and 10"; and by omitting the words "7, 9, and 9A", and substituting the words "7 and 9":
- (f) By omitting from subclause (6) the words "full cream cheese", and substituting the words "whole milk cheese":
- (g) By omitting from subclause (6) the words "7, 9, and 9A", and substituting the words "7 and 9".

6. Regulation 26 of the principal regulations is hereby amended by omitting from paragraph (c) of subclause (2) the words "Full cream", and substituting the words "Whole milk".

7. (1) Regulation 32 of the principal regulations, as amended by regulation 16 of the Dairy Produce Regulations 1938, Amendment No. 4, is hereby further amended as follows:

- (a) By revoking paragraphs (a) and (c) of subclause (1), and substituting the following paragraph:
 - "(a) N.Z. cheddar cheese which shall include all cheese manufactured at a manufacturing dairy registered as a cheese factory or a standardized cheese factory":

(b) By omitting from subclause (2) and subclause (3) the words "full cream cheese or 52% fat cheese", and substituting in each case the words "N.Z. cheddar cheese".

(2) Paragraph (a) of regulation 16 of the Dairy Produce Regulations 1938, Amendment No. 4, is hereby revoked.

8. Regulation 34 of the principal regulations, as amended by regulation 17 of the Dairy Produce Regulations 1938, Amendment No. 4, is hereby further amended by omitting from paragraph (b) of subclause (1) the words "full cream cheese or 52% fat cheese", and substituting the words "N.Z. cheddar cheese".

9. (1) The Second Schedule to the principal regulations, as amended by regulation 19 of the Dairy Produce Regulations 1938, Amendment No. 4, is hereby further amended as follows:

(a) By revoking the forms numbered 6, 6A, 9, 9A, 10, 10A, and 14, and substituting the forms numbered 6, 9, 10, and 14, in the Schedule hereto:

(b) By omitting from the form numbered 18 the words "' Full Cream ' (' 52% Fat ') Cheese '", and substituting the words "N.Z. Cheddar Cheese".

(2) Paragraphs (a), (b), and (c) of regulation 19 of the Dairy Produce Regulations 1938, Amendment No. 4 are hereby revoked.

10. (1) Regulation 8 of the Dairy Produce Regulations 1938, Amendment No. 3, as amended by regulation 2 of the Dairy Produce Regulations 1938, Amendment No. 7, is hereby further amended as follows:

(a) By omitting from paragraph (a) the words "At a rate of 0·0291d.", and substituting the words "at a rate of 0·037d.":

(b) By omitting from paragraph (b) the words "at a rate of 0·0137d.", and substituting the words "at a rate of 0·017d.".

(2) The Dairy Produce Regulations 1938, Amendment No. 7, are hereby revoked.

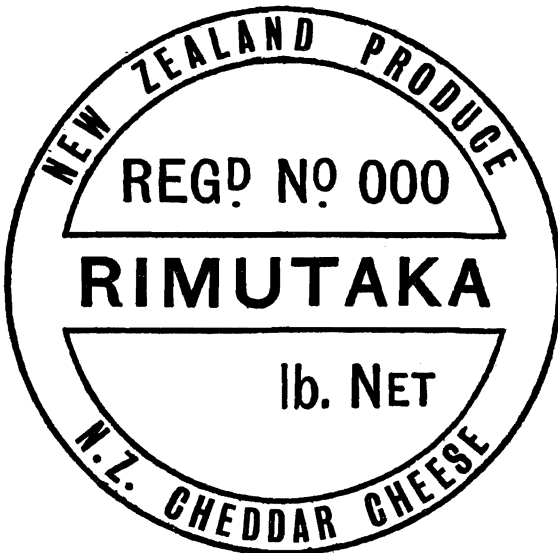

EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

These regulations make amendments to the principal regulations consequential on a decision to have all cheese exported from New Zealand termed "N.Z. Cheddar Cheese" instead of "Full Cream Cheese" or "52% Fat Cheese" as was previously the case.

In addition, the dairy produce grading levy has been increased.
