**THE DAIRY PRODUCE REGULATIONS 1938,
AMENDMENT NO. 16**

ORDER IN COUNCIL

At the Government House at Wellington this 30th day of October 1957

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Dairy Industry Act 1952, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Dairy Produce Regulations 1938, Amendment No. 16, and shall be read together with and deemed part of the Dairy Produce Regulations 1938* (hereinafter referred to as the principal regulations).

2. (1) Regulation 18 of the principal regulations is hereby amended by omitting from subclause (1A), as substituted by regulation 5 of the Dairy Produce Regulations 1938, Amendment No. 11, the words "or casein factory", and substituting the words "casein factory, or dried milk factory".

(2) Regulation 18 of the principal regulations is hereby further amended by omitting from subclause (4) the words "1d. per pound", and substituting the words "2d. per pound".

(3) Regulation 18 of the principal regulations is hereby further amended by revoking subclause (6), and substituting the following subclause:

"(6) All whole milk cream or whey cream containing less than 36 per cent, but not less than 35 per cent, by weight, of butterfat shall be paid for at a rate of at least 1d. per pound of butterfat less than the rate that would otherwise have been payable for it according to its grade, and all such cream containing less than 35 per cent, by weight,

shall be paid for at a rate of at least 2d. per pound of butterfat less than the rate that would otherwise have been payable for it according to its grade."

3. (1) Regulation 8 of the Dairy Produce Regulations 1938, Amendment No. 3, as amended by regulation 10 of the Dairy Produce Regulations 1938, Amendment No. 10, is hereby further amended as follows:

- (a) By omitting from paragraph (a) the words "at a rate of 0·037d.", and substituting the words "at a rate of 0·0423d.";
- (b) By omitting from paragraph (b) the words "at a rate of 0·017d.", and substituting the words "at a rate of 0·0198d.".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

Clause 2 varies the rates payable in respect of low test cream and low grade cream and milk so that the rates for any such cream or milk are lower than usual rates.

Clause 3 increases the levy payable in respect of the grading of butter and cheese.
