THE DAIRY PRODUCE REGULATIONS 1938, AMENDMENT NO. 27

Pursuant to the Dairy Industry Act 1952, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Dairy Produce Regulations 1938, Amendment No. 27, and shall be read together with and deemed part of the Dairy Produce Regulations 1938* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.
- 2. Weighing milk and cream—Regulation 12 of the principal regulations (as amended by regulation 6 of the Dairy Produce Regulations 1938, Amendment No. 1) is hereby amended by revoking subclause (6), and substituting the following subclause:
- "(6) Every owner upon weighing any cream delivered to his manufacturing dairy shall, where the weight is an exact number of pounds, record the weight accordingly, and where the weight is not an

exact number of pounds record it at the nearest pound to the exact weight; and if any such cream is weighed in a container shall compute the tare in accordance with the provisions of subclause (4) hereof:

- "Provided that where the weight of the cream is an exact number of half-pounds, the nearest pound to the exact weight shall be deemed to be the next half-pound above the exact weight."
- 3. Ports and grading stores for export butter and cheese—Regulation 30 of the principal regulations (as amended by the regulations revoked by paragraphs (b) to (g) of regulation 4 hereof) is hereby further amended by revoking subclauses (1) and (2), and substituting the following subclauses:
- "(1) The ports of Opua, Auckland, Whangarei, Tauranga, Gisborne, New Plymouth, Patea, Wellington, Nelson, Lyttelton, Timaru, Dunedin, and Bluff are hereby appointed to be the only ports at which dairy produce may lawfully be exported.
- "(2) The buildings referred to in this subclause are hereby appointed to be stores for the storage, cooling, or freezing of dairy produce before export, that is to say—
 - "(a) The stores of the Auckland Farmers' Freezing Co-operative Limited at Moerewa, Whangarei, Auckland, Southdown, Horotiu, and Mount Maunganui:
 - "(b) The store of the Gisborne Sheepfarmers Freezing Company Limited at Gisborne, held under lease by the Gisborne Refrigerating Company Limited:
 - "(c) The stores of the Taranaki Producers Freezing Company Limited at Moturoa and Patea:
 - "(d) The store of the Co-operative Dairy Producers Freezing Company Limited at Wellington:
 - "(e) The store of the Nelson Freezing Company Limited at Stoke:
 - "(f) The store of the Taitapu Central Co-operative Dairy Company Limited at Christchurch:
 - "(g) The store of Christchurch Cool Stores Limited at Christchurch:
 - "(h) The store of the Lyttelton Harbour Board at Lyttelton:
 - "(i) The store of the South Canterbury Co-operative Cool Stores Limited at Timaru:
 - "(j) The store of the Otago Dairy Producers Cool Storage Company Limited at Dunedin:
 - "(k) The store of the Southland Cool Stores Limited at Bluff."
- "(2A) The buildings referred to in subclause (2) of this regulation do not include any substantial additions thereto made after the commencement of this subclause unless the use of the addition has been approved."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Dairy Produce Regulations 1938.

Regulation 2 of these regulations amends regulation 12 of the principal regulations and provides that cream shall be weighed to the nearest pound. The port of Napier has been omitted from, and the port of Tauranga has been added to, the list of ports at which butter or cheese may lawfully be exported. A number of changes are made in the list of stores appointed for the storage, cooling, or freezing of dairy produce before export. A number of consequential revocations are made by regulation 4 of these regulations.
