# THE DAIRY PRODUCE REGULATIONS 1938, AMENDMENT NO. 29

# ORDER IN COUNCIL

At the Government House at Wellington this 6th day of August 1973

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Dairy Industry Act 1952, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

# REGULATIONS

1. Title—These regulations may be cited as the Dairy Produce Regulations 1938, Amendment No. 29, and shall be read together with and deemed part of the Dairy Produce Regulations 1938\* (hereinafter referred to as the principal regulations).

2. Payment for graded milk or cream—(1) Regulation 18 of the principal regulations is hereby amended by omitting from subclause (2) the words "1c per pound", and substituting the words "2.3c per kilogram", and also by omitting the words "3c per pound", and substituting the expression "6.7c per kilogram".

(2) The said regulation 18 is hereby further amended by omitting from subclause (3) the words "1c per pound", and substituting the words "1.2c per kilogram", and also by omitting the words "2c per pound", and substituting the words "4.5c per kilogram".

(3) The said regulation 18 is hereby further amended by omitting from subclause (4) the words "2c per pound", and substituting the expression "4.5c per kilogram".

(4) The said regulation 18 is hereby further amended by omitting from subclause (5) the words "1c per pound", and substituting the words "2.3c per kilogram", and also by omitting the words "2c per pound", and substituting the words "4.5c per kilogram".

(5) The said regulation 18 is hereby further amended by omitting from subclause (11) the words "5c per pound", and substituting the words "11c per kilogram".

**3. Dairy produce grading levy**—(1) Regulation 8 of the Dairy Produce Regulations 1938, Amendment No. 3 (as amended by regulation 2 of the Dairy Produce Regulations 1938, Amendment No. 28) is hereby further amended—

- (a) By omitting from paragraph (a) the words "at a rate of 0.0756c per pound", and substituting the words "at a rate of 0.2833c per kilogram", and also by omitting the word "pounds", and substituting the word "kilograms":
- (b) By omitting from paragraph (b) the words "at a rate of 0.0353c per pound", and substituting the words "at a rate of 0.1322c per kilogram", and also by omitting the word "pounds", and substituting the word "kilograms".

(2) The said regulation 8 is hereby further amended by adding the following paragraph:

"(c) In respect of anhydrous milkfat, at a rate of 0.0674c per kilogram and computed on the total number of kilograms of anhydrous milkfat manufactured by the owner during any financial year as disclosed by the accounts and balance sheet of the owner for that year."

4. Revocation—The Dairy Produce Regulations 1938, Amendment No. 28, are hereby consequentially revoked.

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

Regulation 2 of the regulations amends regulation 18 of the principal regulations to express various rates in metric quantities, rounded up to the first decimal place.

Regulation 3 amends regulation 8 of the Dairy Produce Regulations 1938, Amendment No. 3 by increasing the dairy produce grading levy for butter from 0.0756c per lb to 0.1285c per lb (now expressed as 0.2833c per kg), and the dairy produce grading levy for cheese from 0.0353c per lb to 0.0600c per lb (now expressed as 0.1322c per kg). A new levy is prescribed for anhydrous milkfat of 0.0674c per kg.
