ORDER IN COUNCIL

At the Government House at Wellington this 29th day of July 1974

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Dairy Industry Act 1952, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Dairy Produce Regulations 1938, Amendment No. 30, and shall be read together with and deemed part of the Dairy Produce Regulations 1938* (hereinafter referred to as the principal regulations).

- (2) These regulations shall come into force on the 1st day of August 1974.
- 2. Dairy produce grading levy—(1) Regulation 8 of the Dairy Produce Regulations 1938, Amendment No. 3 (as amended by regulation 3 of the Dairy Produce Regulations 1938, Amendment No. 29) is hereby further amended by revoking paragraphs (a) to (c), and substituting the following paragraphs:
 - "(a) In respect of butter, at a rate of 0.3116c per kilogram and computed on the total number of the kilograms of creamery butter and whey butter manufactured by the owner during any financial year as disclosed by the accounts and balance sheet of the owner for that year:

"(c) In respect of anhydrous milkfat, at a rate of 0.0741c per kilogram and computed on the total number of kilograms of anhydrous milkfat manufactured by the owner during any financial year as disclosed by the accounts and balance sheet of the owner for that year."

(2) Regulation 3 of the Dairy Produce Regulations 1938, Amendment No. 29, is hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Dairy Produce Regulations 1938, Amendment No. 3, and come into force on 1 August 1974.

The effect is to increase the dairy produce grading levy for butter from 0.2833c to 0.3116c per kg, the dairy produce grading levy for cheese from 0.1322c to 0.1454c per kg, and the dairy produce grading levy for anhydrous milkfat from 0.0674c to 0.0741c per kg.
