## THE DAIRY PRODUCE SUPERANNUATION LEVY REGULATIONS 1973

ORDER IN COUNCIL

At the Government House at Wellington this 28th day of May 1973

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Dairy Board Act 1961, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Dairy Produce Superannuation Levy Regulations 1973.

(2) These regulations shall come into force on the 1st day of June 1973.

2. Maximum amount of special levy—The maximum amount by way of a special levy that may be fixed by the Board under section 45 of the Act on dairy produce manufactured or intended to be manufactured for sale shall be \$0.004 per kilogram of the milkfat received per month by a manufacturer for manufacture of the produce.

3. Levy payable to the Board—Any levy fixed by the Board in accordance with regulation 2 of these regulations shall be paid to the Board by each manufacturer not later than the 20th day of the month immediately following the month in which the milkfat to which the levy relates was received by the manufacturer, or, at the discretion of the Board, may be deducted from any money held by the Board for the credit of the manufacturer.

4. Manufacturers to furnish monthly returns—Every manufacturer shall furnish or cause to be furnished to the Board as soon as practicable after the last day of each month a return in accordance with a form to be provided by the Board giving information of the total milkfat received during that month and to which these regulations relate. The return shall be certified correct by the person making the return.

5. Revocations—The following regulations are hereby consequentially revoked—

(a) The Dairy Produce Superannuation Levy Regulations 1952\*:

(b) The Dairy Produce Superannuation Levy Regulations 1952, Amendment No. 4<sup>+</sup>.

#### **EXPLANATORY NOTE**

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations are made in substitution for the Dairy Produce Superannuation Levy Regulations 1952, and prescribe the maximum amount of a special levy that may be fixed by the New Zealand Dairy Board under section 45 of the Dairy Board Act 1961. The present maximum amount of \$0.0018 per pound of milkfat is re-expressed as \$0.004 per kilogram. The levy may be fixed for the purposes of contributing towards a superannuation scheme for the employees of dairy companies.
