## THE DAIRY-PRODUCE REGULATIONS 1938, AMENDMENT NO. 1

ORDER IN COUNCIL.

At the Government House at Wellington, this 4th day of February, 1942.

## Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

Pursuant to the Dairy Industry Act, 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

## REGULATIONS.

- 1. These regulations may be cited as the Dairy-produce Regulations 1938, Amendment No. 1.
- 2. These regulations shall be read together with and form part of the Dairy-produce Regulations 1938\* (hereinafter called the principal regulations).
- 3. These regulations shall come into force on the seventh day after notification in the *Gazette* of the making hereof†.
  - 4. Regulation 4 of the principal regulations is amended as follows:—
    - (i) By revoking from clause (7) thereof the words "used in the erection":
    - (ii) By inserting, next after clause (7) thereof, the following additional clause:—
      - "(7A) All unions and other fittings of the milkingmachine secured by solder to any pipe or other part of the milking-plant to which they are affixed shall be sweated solid thereto."
- 5. Clause (1) of Regulation 5 of the principal regulations is amended by inserting, next after the word "utensils", the words "used in milking or".

**6.** Regulation 12 of the principal regulations is amended as follows:—

(i) By revoking clause (3) thereof, and substituting therefor

the following clause:-

"(3) Every owner, upon weighing any milk delivered to his manufacturing dairy, shall, where the weight is an exact number of pounds, record the weight accordingly, and where the weight is not an exact number of pounds record it at the nearest pound to the exact weight:

"Provided that where the weight is an exact number of half-pounds the nearest pound to the exact weight shall be deemed to be the next half-pound above the

exact weight."

(ii) By revoking clause (4) thereof, and substituting therefor

the following clause:—

"(4) Every owner shall, where any cream is weighed in a container, ascertain and mark on such container the weight thereof, which shall be recorded at an exact number of half-pounds or at the nearest half-pound to the exact weight:

"Provided that where the weight of the container is an exact number of quarter-pounds the nearest half-pound to the exact weight shall be deemed to be the next

quarter-pound below the exact weight."

(iii) By revoking clause (6) thereof, and substituting therefor

the following clause:—

"(6) Every owner upon weighing any cream delivered to his manufacturing dairy shall, where the weight is an exact number of half-pounds, record the weight accordingly, and where the weight is not an exact number of half-pounds record it at the nearest half-pound to the exact weight; and if any such cream is weighed in a container shall compute the tare in accordance with the provisions of clause (4) hereof:

"Provided that where the weight of the cream is an exact number of quarter-pounds the nearest half-pound to the exact weight shall be deemed to be the next

quarter-pound above the exact weight."

7. Clause (17) of Regulation 13 of the principal regulations is amended by revoking from the proviso to the said clause the words "below the actual reading", and substituting therefor the words "above the actual reading".

8. Clause (1) of Regulation 16 of the principal regulations is amended by inserting at the commencement of the said clause the following words: "Subject to the provisions of clause (16) hereof".

9. Regulation 20 of the principal regulations is amended as follows:—

(i) By adding to clause (2) thereof the following additional paragraph:—

"(d) The delivery or supply of which would constitute a breach of the said Act or of these regulations or of any lawful order given by an Inspector under the said Act":

(ii) By revoking paragraph (c) of clause (3) thereof.

- 10. Clause (3) of Regulation 29 of the principal regulations is amended as follows:—
  - (i) By revoking next after the words "shall measure" the words and figures "not less than 15", and substituting therefor the figures "15½":
  - (ii) By revoking next after the words "affixed to the" the word "crate", and substituting therefor the word "battens".
- 11. Clause (4) of Regulation 29 of the principal regulations is amended by revoking the last sentence thereof, and substituting therefor the following: "Each batten shall be planed smooth on the outside and shall be affixed to each end board and the centre board respectively by two flat-headed cement-coated nails  $1\frac{3}{4}$  in. long of No. 13 gauge".
- 12. Clause (2) of Regulation 30 of the principal regulations is amended by revoking the words "The Wanganui Cold Storage Co., Ltd., at Castlecliff", and substituting therefor the words "The Wanganui Harbour Board's cold store at Castlecliff".
