

THE DIETITIANS REGULATIONS 1975, AMENDMENT NO. 1

ORDER IN COUNCIL

At the Government House at Wellington this 25th day of January 1977

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Dietitians Act 1950, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Dietitians Regulations 1975, Amendment No. 1, and shall be read together with and deemed part of the Dietitians Regulations 1975* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of February 1977.

2. Fees—The principal regulations are hereby amended by revoking regulation 18, and substituting the following regulation:

"18. (1) The fee for admission to the State Examination for Dietitians shall be \$25.

"(2) The fee for re-examination shall be 10 for each paper in which the applicant is re-examined.

"(3) The fee for registration shall be \$20:

Provided that no such fee shall be payable in respect of an application for registration by a dietitian already registered by law in any overseas country who is temporarily employed in a hospital in New Zealand on exchange for not more than 12 months with a dietitian who is registered in New Zealand and similarly employed in that overseas country.

"(4) The fee for the issue of a certificate of registration shall be \$3.

"(5) The fee for the issue of a certificate of temporary registration shall be \$10.

"(6) The fee for the restoration of a name to the register, pursuant to an application under section 16 (4) of the Act, shall be \$5.

"(7) The fee for the issue of an annual practising certificate shall be \$8.

"(8) The fee for the correction of a name in the register pursuant to an application under section 18 (2) of the Act shall be \$5.

"(9) All fees shall be paid in cash at the time of application."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Dietitians Regulations 1975.

Regulation 1 relates to the Title and commencement. The regulations come into force on 1 February 1977.

Regulation 2 substitutes a new and increased scale of fees in respect of the various matters specified in the regulation. For the first time a fee is prescribed for the issue of a temporary certificate of registration, and for the correction of a name in the Register of Dietitians pursuant to an application under section 18 (2) of the Act. The present exemption from payment of the registration fee in respect of applications under section 10 (1) (b) of the Act has been omitted.
