

THE DIETITIANS REGULATIONS 1987, AMENDMENT NO. 8

ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to section 32 (2) (e) of the Dietitians Act 1950, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Dietitians Regulations 1987, Amendment No. 3, and shall be read together with and deemed part of the Dietitians Regulations 1987* (hereinafter referred to as the principal regulations).
 - (2) These regulations shall come into force on the 1st day of April 1990.
- 2. Fees—The principal regulations are hereby amended by revoking regulation 20 (as substituted by regulation 2 of the Dietitians Regulations 1987, Amendment No. 2), and substituting the following regulation:

"20. (1) The fee for admission to the State Examination for Dietitians shall be \$146.00.

"(2) The fee for re-examination shall be \$146.00 for each paper in which

the applicant is re-examined.

- "(3) The fee for an application for registration shall be \$73.00 except in the case of an application for registration by an applicant who is registered as a dietitian in any other country and temporarily employed in a hospital in New Zealand on exchange for not more than 12 months with a dietitian who is registered in New Zealand and similarly employed in that other country, in which case no fee shall be payable under this subclause.
 - "(4) The fee for the issue of a certificate of registration shall be \$24.00.
- "(5) The fee for the issue of a certificate of temporary registration shall be \$49.00.
- "(6) The fee for the restoration of a name to the register, pursuant to an application under section 16 (4) of the Act, shall be \$43.00.
 - ¹(7) The fee for the issue of an annual practising certificate shall be

- "(8) The fee for the correction of a name in the register, pursuant to an application under section 18 (2) of the Act, shall be \$12.00."
- **3. Fees inclusive of goods and services tax**—The fees fixed by these regulations are inclusive of goods and services tax under the Goods and Services Tax Act 1985.
- **4. Revocation**—The Dietitians Regulations 1987, Amendment No. 2 are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 April 1990, prescribe a new and increased scale of fees payable under the Dietitians Act 1950.

The fees prescribed are inclusive of goods and services tax.
