## ORDER IN COUNCIL

At Wellington this 29th day of May 1989

THE RIGHT HON. G. W. R. PALMER PRESIDING IN COUNCIL

PURSUANT to section 83 of the Dental Act 1988, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council and on the advice of the Minister of Health given after consultation by the Minister with the Dental Council and the Dental Technicians Board, hereby makes the following regulations.

### **REGULATIONS**

- 1. Title and commencement—(1) These regulations may be cited as the Dental Regulations 1988, Amendment No. 1, and shall be read together with and deemed part of the Dental Regulations 1988\* (hereinafter referred to as the principal regulations).
  - (2) These regulations shall come into force on the 1st day of July 1989.
- **2. Fees**—The principal regulations are hereby amended by revoking the Schedule, and substituting the Schedule set out in the Schedule to these regulations.

## **EXPLANATORY NOTE**

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 July 1989, increase the fees payable to the Dental Council and the Dental Technicians Board in respect of applications for registration and the issue of certain certificates. The increases simply reflect the change in the rate of goods and services tax from 10 percent to 12.5 percent.
