THE DRUG TARIFF 1953, AMENDMENT NO. 12

Pursuant to section 90 of the Social Security Act 1938, the Minister of Health hereby gives the following direction:

- 1. This direction may be cited as the Drug Tariff 1953, Amendment No. 12, and shall be read together with and deemed part of the Drug Tariff 1953* (hereinafter referred to as the Drug Tariff).
- 2. (1) The Seventh Schedule to the Drug Tariff is hereby amended by revoking rule 13, as substituted by clause 4 (1) of the Drug Tariff 1953, Amendment No. 10, and amended by clause 2 of the Drug Tariff 1953, Amendment No. 11, and substituting the following rule:
- "13. Application to Prescription Pricing Supplements—For the purpose of payment of pharmaceutical benefits claims, the pricing of a medical prescription in accordance with rule 1 of this Schedule shall apply to—
 - "(a) The Official Schedules and Rules for Prescription Pricing (November 1955) issued by the Department of Health, in respect of all claims and supporting prescriptions, whatever the date thereof, received by a Medical Officer of Health on or after the 16th day of November 1955:
 - "(b) The Prescription Pricing Supplement 1956/1, issued by the said Department, in respect of all claims and supporting prescriptions, whatever the date thereof, received by a Medical Officer of Health on or after the 16th day of February 1956:
 - "(c) The Prescription Pricing Supplement 1956/2, issued by the said Department, in respect of all claims and supporting prescriptions, whatever the date thereof, received by a Medical Officer of Health on or after the 16th day of May 1956:
 - "(d) The Prescription Pricing Supplement 1956/3, issued by the said Department, in respect of all claims and supporting prescriptions, whatever the date thereof, received by a Medical Officer of Health on or after the 16th day of August 1956."
