# THE DENTAL TECHNICIANS REGULATIONS 1968, AMENDMENT NO. 2

## ORDER IN COUNCIL

At the Government House at Wellington this 6th day of December 1976

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Medical and Dental Auxiliaries Act 1966, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Dental Technicians Regulations 1968, Amendment No. 2, and shall be read together with and deemed part of the Dental Technicians Regulations 1968\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 1st day of April 1977.
- 2. Qualifications for registration—Regulation 4 of the principal regulations is hereby amended by omitting from paragraph (c) of subclause (1) the words "Technicians Certification Act 1958", and substituting the words "Technicians Training Act 1967".
- 3. Temporary registration of persons visiting New Zealand—Regulation 6 of the principal regulations is hereby amended by revoking subclause (4).
- 4. Exceptions to statutory prohibition—Regulation 11 of the principal regulations is hereby amended by omitting from paragraph (d) of subclause (1) the words "prescribed course of training", and substituting the words "course of training prescribed under the Act or under the Technicians Training Act 1967".

- 5. Fees—The principal regulations are hereby amended by revoking regulation 16, and substituting the following regulation:
  - "16. (1) The fee for registration as a dental technician shall be \$20.

"(2) The fee for a certificate of registration as a dental technician shall be \$3.

"(3) The fee for a provisional certificate entitling a person to perform dental technician's work shall be \$2.

"(4) The fee for an annual licence issued to a registered dental

technician shall be \$8.

"(5) The fee for any alteration in or addition to an entry in the register, other than a change of address or correction of an error for which the person registered is not responsible, shall be \$5.

"(6) The fee for restoration of a name to the register under section

21 of the Act shall be \$5.

"(7) The fee for inspection of the register shall be \$5.
"(8) The fee for temporary registration as a dental technician shall be \$10."

## **EXPLANATORY NOTE**

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations provide for increases in fees, and make other amendments designed to bring the principal regulations into line with the Dental Technician Training Council Order 1973, which was published in the Gazette, 1973, Vol. 1, p. 683.
