THE EXAMINATION AND CERTIFICATION OF TEACHERS REGULATIONS 1961, AMENDMENT NO. 1

PURSUANT to the Education Act 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Examination and Certification of Teachers Regulations 1961, Amendment No. 1, and shall be read together with and deemed part of the Examination and Certification of Teachers Regulations 1961* (hereinafter referred to as the principal regulations).

2. Regulation 11 of the principal regulations is hereby amended by omitting the words "(8) Social Studies in History and Geography", and substituting the words "(8) Social Studies".

3. Regulation 17 of the principal regulations is hereby amended by revoking paragraph (c) of the portion of the regulation relating to subject numbered (1), *English*, and substituting the following paragraph:

(c) The Teaching of English: Aims, content, and method in the teaching of primary-school English. Candidates will be expected to be familiar with the current primary-school syllabus in language, which includes oral and written English, reading, spelling, and handwriting:".

4. Regulation 17 of the principal regulations is hereby further amended by revoking subparagraph (v) of paragraph (a) of the portion of the regulation relating to the *Practical Requirements* for subject numbered (5), *Physical Education*, and substituting the following subparagraph: "(v) Folk and country dancing, including at least three dances of

each kind, knowledge of terms and steps, and ability to demonstrate the dance; or ability to teach movement exploration and creative dance:". 5. Regulation 17 of the principal regulations is hereby further amended—

- (a) By omitting the words "(8) Social Studies in History and Geography", and substituting the words "(8) Social Studies":
- (b) By omitting the words "in history and geography" where they next appear.

6. Regulation 17 of the principal regulations is hereby further amended by revoking paragraph (c) of the portion of the regulation relating to subject numbered (17), Art and Crafts (including Needlework for women candidates), and substituting the following paragraph:

"(c) Practical Test (four hours for men and two hours for women): Candidates will be expected to have had practical experience in all of the following activities:

Design for fabrics:

Illustration in wash or in pen and ink, or in both:

Cloth and paper collage:

Interpretative painting:

Designing of poster or book jacket:

Designing of a mural.

In the practical test, men candidates will be required to answer two questions on the activities listed above. Women candidates will be required to answer one question on the activities listed above and to complete to a satisfactory standard, by 31 January of the year following the date of the examination, any four garments selected from those listed in the Form II prescription of the current official primaryschool syllabus in Sewing."
