THE EXAMINATION AND CERTIFICATION OF TEACHERS REGULATIONS 1961, AMENDMENT NO. 9

At the Government Buildings at Wellington this 23rd day of July 1979

THE HON. D. MACINTYRE PRESIDING IN COUNCIL

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Examination and Certification of Teachers Regulations 1961, Amendment No. 9, and shall be read together with and deemed part of the Examination and Certification of Teachers Regulations 1961* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 14th day after the date of their notification in the *Gazette*.

2. Academic requirements for certificates—(1) Regulation 9 (2) of the principal regulations is hereby amended by revoking paragraphs (b) and (c) (as amended by regulation 2 of the Examination and Certification of Teachers Regulations 1961, Amendment No. 6 and regulation 2 of the Examination and Certification of Teachers Regulations 1961, Amendment No. 3), and substituting the following paragraphs:

"(b) Have obtained a Trained Teachers Certificate, and have been credited with not less than two-thirds of a degree or diploma covering a course of not less than 3 years in any university faculty or university department recognised by the Director-General for the purpose; or

"(c) Have obtained a Trained Teachers Certificate, and have been credited with-

> (i) Not less than one-third of a degree or diploma covering a course of not less than 3 years in any university faculty or university department recognised by the Director-General for the purpose; and

> "(ii) Such other papers and credits in other examinations, courses and assignments, approved by the Director-General for the purpose as, in the opinion of the Director-General, when taken together with the credits specified in subparagraph (i) of this paragraph, are the equivalent of not less than two-thirds of a degree or diploma of at least 3 years at a New Zealand university; or

- "(d) Have obtained a Trained Teachers Certificate, and have been credited with not less than 5 units of any degree, covering a course of not less than 3 years study in any university faculty or university department recognised by the Director-General for the purpose, if that degree comprises 8 units."
- (2) The following provisions are hereby consequentially revoked:
- (a) Regulation $\breve{2}$ (1) of the Examination and Certification of Teachers Regulations 1961, Amendment No. 3:
- (b) Regulation 2 (2) (b) of the Examination and Certification of Teachers Regulations 1961, Amendment No. 3:
- (c) The Examination of Teachers Regulations 1961, Amendment No. 6.

3. Revocations—The following regulations are hereby revoked:

- (a) The Examination and Certification of Teachers Regulations 1961, Amendment No. 1:
- (b) The Examination and Certification of Teachers Regulations 1961, Amendment No. 5.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the provisions of the principal regulations that specify the academic requirements for the award of a Diploma in Teaching, to take account of alterations in the structure of degree courses at New Zealand universities in recent years.

The opportunity is taken to revoke 2 amendments to the principal regulations that are now spent.
