### 1 Title This order is the Excise and Excise-Equivalent Duties (Motor Spirits Indexation) Amendment Order 2006.

Schedule 3 of the Customs and Excise Act 1996 is amended by revoking so much as relates to Excise item numbers 99.75.15C and 99.75.18H, and Tariff items 2710.19.11 and 2710.19.29, and substituting the Excise item numbers and Tariff items and rates of duty specified in the Schedule.
