ORDER IN COUNCIL

At Wellington this 17th day of July 1989

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to sections 165D and 203 of the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Education Authorities Employment Regulations 1982, Amendment No. 3, and shall be read together with and deemed part of the Education Authorities Employment Regulations 1982\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 28th day after the date of their notification in the *Gazette*.

**2. Retirement**—(1) Regulation 44 of the principal regulations is hereby amended by revoking subclause (4), and substituting the following subclause:

“(4) Subject to subclauses (1), (2), (3), and (7) of this regulation, every employee shall retire upon attaining the age of 60 years.”

(2) Regulation 44 of the principal regulations is hereby further amended by adding the following subclause:

“(7) Any employee—

“(a) Who has attained the age of 50 years; and

“(b) Who has completed—

“(i) At least 10 years’ actual service; or

“(ii) At least 10 years’ contributory service within the meaning of section 2 of the Government Superannuation Fund Act 1956; and

“(c) Who has given to the Education Authority at least three months’ notice of the employee’s intention to retire (being a period of notice expiring before the date on which that employee attains the age of 60 years); and

“(d) Who has received from the Education Authority its consent to his or her retirement,—

shall retire at the expiration of that period of notice.”

**3. Retirement leave**—(1) Regulation 45 (1) (a) of the principal regulations is hereby amended by inserting, after the expression “paragraph (b)”, the expression “or paragraph (ba)”.

(2) Regulation 45 (2) of the principal regulations is hereby amended by inserting, after paragraph (b), the following paragraph:

“(ba) In accordance with regulation 44 (7) of these regulations; or”.

#### EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations amend the Education Authorities Employment Regulations 1982.

The amendments introduce early retirement provisions in relation to employees to whom those regulations apply.

The provisions are related to those which apply under section 61(4) of the Government Superannuation Fund Act 1956. That section deals with the entitlement to an annual retiring allowance of a contributor who ceases to be employed in the Government service.
