# ORDER IN COUNCIL

At the Government Buildings at Wellington this 8th day of June 1966

Present:

PURSUANT to the Engineering Associates Act 1961, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

# REGULATIONS

1. (1) These regulations may be cited as the Engineering Associates Fees Regulations 1966.

(2) These regulations shall come into force on the day after the date of their notification in the Gazette.

2. In these regulations, unless the context otherwise requires,-

"The Act" means the Engineering Associates Act 1961:

- "Association" means an Association or Institute or organisation to which the Minister, by notice published in the *Gazette* and not in like manner revoked or suspended, has declared that the Act shall apply, being an Association or Institute or organisation whose rules and objects satisfy the requirements specified in the Schedule to the Act:
- "Register" means the register kept by the Registrar under subsection (4) of section 11 of the Act.

3. The several fees specified in the Schedule hereto shall be paid for the matters therein specified.
