THE EDUCATION AMENDING REGULATIONS 1941.

ORDER IN COUNCIL.

At the Government House at Wellington, this 22nd day of
October, 1941.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to the Education Act, 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

1. (1) These regulations may be cited as the Education Amending Regulations 1941.

(2) Except as otherwise provided herein, these regulations shall come into force on the day following publication of a notification in the *Gazette* of the making thereof.

2. These regulations are divided into Parts, as follows :—

Part I.—Teachers Salaries.

Part II.—Probationary Assistants.

Part III.—Training-colleges.

Part IV.—Organization and Management of Public Schools.

Part V.—School Certificate Examination.

PART I.—TEACHERS SALARIES.

3. This Part of these regulations shall be read together with and deemed part of the Teachers' Salaries Regulations 1938* (hereinafter in this Part referred to as the principal regulations).

4. Clause 1 of the principal regulations (as heretofore amended by clause 4 of the Teachers' Salaries Regulations 1938, Amendment No. 1)† is hereby further amended by adding thereto the following :—

“Section 20.—Physical Education. (Clauses 112 and 113).”

5. Clause 4 of the principal regulations (as heretofore amended by clause 5 of the Teachers' Salaries Regulations 1938, Amendment No. 1)* is hereby further amended by inserting, after the words "correspondence school" in the definition of "teacher", the words "or engaged as a physical-education teacher under section 20 hereof".

6. Clause 7 of the principal regulations is hereby amended by inserting in subclauses (1) and (2) thereof, after the words "Chatham Islands schools", the words "or in the case of a physical-education teacher".

7. Clause 15 of the principal regulations is hereby amended by inserting, after the words "training college" in subparagraph (iv) of paragraph (b) of subclause (6) thereof, the words "or to any teacher whose qualifications are regarded by the Director as equivalent to those of a teacher who has undergone such specialist training".

8. Clause 16 of the principal regulations is hereby amended by omitting the words "leave of absence" in subclause (4) thereof, and substituting the words "sick-leave and all periods of special leave of absence not exceeding three months in the aggregate in any calendar year or such longer period in any particular case as is recommended by the Board and approved by the Director".

9. (1) Clauses 19 and 99 and subclause (3) of clause 104 of the principal regulations are hereby severally amended by omitting the symbols and figures "£209 15s." wherever they occur, and in each case substituting the symbols and figures "£230 8s. 1d.".

(2) This clause shall be deemed to have come into force on the 1st day of October, 1940.

10. (1) Clause 24 of the principal regulations is hereby amended :—

(a) By inserting, after the words "the last preceding clause" in subclause (1), the words "and subject to the provisions of subclause (5) hereof"; and by omitting from the same subclause the words "one year", and substituting the words "three years";

(b) By inserting, after the word "teacher" in subclause (2), the words "other than a teacher referred to in subclause (5) hereof"; and by omitting from the same subclause the words "one year", and substituting the words "three years";

(c) By adding the following subclause :—

"(5) If any teacher holding a permanent position is transferred by the Board, on the grounds of inefficiency or misconduct, to another permanent position, or if a teacher, in accordance with the written request of the Board given on similar grounds, applies for and is appointed to another permanent position under the same Board or any other Board, such teacher shall not be entitled to the benefits of the foregoing provisions of this clause, and in any such case the rate of salary in the new position shall be the commencing rate determined under the provisions of clause 23 hereof, unless the Director approves of a higher rate of salary. On making any appointment or transfer on the grounds mentioned in this subclause the Board making the appointment or transfer shall forthwith notify the same to the Director."

(2) The extension of the period mentioned in subclauses (1) and (2) of clause 24 of the principal regulations effected by paragraphs (a) and (b) of the last preceding subclause shall not apply to any teacher in respect of a position held by him on the date of the coming into force of these regulations or in respect of any position to which he may be appointed after that date on an application made by him before that date.

11. Clause 27 of the principal regulations is hereby amended by adding the following subclause :—

“(5) The provisions of this clause shall apply with respect to the payment of the salaries of probationary assistants in any school and of junior assistants in Native schools.”

12. Clause 82 of the principal regulations is hereby amended by inserting, next after the symbol and figures “ £25 ”, the words “ together with married salary under and subject to the conditions imposed by clause 18 of these regulations ”.

13. The principal regulations are hereby amended by inserting, next after clause 82 thereof, the following additional clause :—

“ 82A. SALARY OF SENIOR ASSISTANT.

“ A male assistant teacher on the staff of the school may be appointed by the Public Service Commissioner as the senior assistant. The senior assistant may be paid salary at the rate of £30 per annum in addition to the salary otherwise prescribed by these regulations.”

14. Clause 87 of the principal regulations is hereby amended by omitting from Schedule XIV thereunder the figures “ 2 ” and “ 5 ” in column (2), and substituting respectively the figures “ 5 ” and “ 6 ”.

15. Clause 102 of the principal regulations is hereby amended by adding to subclause (3) thereof the following words : “ or that, in lieu of boarding-allowance, he may receive a refund of the expenses (not exceeding 10s. a day for a period not exceeding one week) incurred by him for accommodation at a licensed hotel or a private hotel ”.

16. Clause 104 of the principal regulations is hereby amended by adding to subclause (4) thereof the words “ except that on the transfer of a supernumerary teacher at the request of the Director from one education district to another, such transfer expenses as the Director may approve shall be paid ”.

17. Clause 105 of the principal regulations (as added by clause 37 of the Teachers' Salaries Regulations 1938, Amendment No. 1)* is hereby amended as follows :—

(a) By inserting in subclause (4), after the words “ combined school ”, the words “ a Native school, a Native district high school,” :

(b) By adding the following subclause :—

“(7) If a teacher who, in accordance with the foregoing provisions of this clause, is entitled to payment of removal expenses is unable to find suitable accommodation, there may, on the recommendation of the Board and with the approval of the Director, be paid, in addition to such expenses, the cost of storing the teacher's furniture (but not including any of the effects referred to in clause 108 (3) hereof) for a period not exceeding three months.”

18. The principal regulations are hereby further amended by adding thereto the following additional section :—

“SECTION 20.—PHYSICAL EDUCATION. (Clauses 112 and 113.)”

“112. APPOINTMENT OF PHYSICAL-EDUCATION TEACHERS.

“(1) The Public Service Commissioner may from time to time appoint, as officers of the Education Department, such number of physical-education teachers as he thinks fit, to fill respectively the positions of Area Organizer, Assistant Organizer, Senior Teacher at a teachers' training-college, Assistant at a teachers' training-college, and Junior Assistant at a teachers' training-college. Any suitable person may be appointed under this clause, notwithstanding that he may not be a certificated teacher.

“(2) The following provisions of the principal regulations shall, so far as applicable, apply with respect to certificated teachers appointed under this clause—that is to say, clause 15 (basic salary); clause 16 (definition of service); clause 17 (position salary); clause 18 (married salary); clause 27 (period for which teacher entitled to be paid); and clause 28 (payment of salary on death of teacher).”

“113. SALARIES OF PHYSICAL-EDUCATION TEACHERS.

“(1) The salaries of certificated physical-education teachers shall be those prescribed in columns (2) and (3) of Schedule XVII hereunder for the respective positions shown in column (1) of the said Schedule.”

“SCHEDULE XVII.—SALARIES OF PHYSICAL-EDUCATION TEACHERS.

“(2) In the case of any Assistant Organizer or of any Junior Assistant at a teachers' training-college the Public Service Commissioner shall from time to time determine whether the position salary to which the teacher is for the time being entitled in accordance with the foregoing Schedule shall be £30 or £50.

“(3) Uncertificated teachers appointed under this clause shall be paid salaries at such rates as the Public Service Commissioner may determine (not exceeding in any case the rate that would be payable to the teacher if he were a certificated teacher).”

TRAVELLING-EXPENSES OF SPECIALIST TEACHERS.

19. A teacher who is required by the Board to travel from school to school in the course of his duties may with the approval of the Director receive a refund of the actual and reasonable travelling-expenses incurred by him in the course of his duties and, with the approval of the Director, may also receive a travelling-allowance at a rate not exceeding 12s. 6d. a day to be payable under the conditions laid down in the Public Service Regulations.

PART II.—PROBATIONARY ASSISTANTS.

20. Clause 1 of the regulations relating to probationary assistants made under the Education Act, 1914, by Part XI of the Order in Council dated the 22nd day of March, 1926, and published in the *Gazette* of the 25th day of the same month, is hereby amended by adding the following subclauses :—

“(3) If at any time the number of probationary assistants attached to schools in any education district is in excess of the number prescribed for all the schools in that district it shall be the duty of the Board to report the fact to the Director, who may require the Board to release any specified or unspecified probationary assistants for transfer to schools in any other education district.

“(4) In any case where a probationary assistant is obliged by reason of his appointment to live away from home or where a probationary assistant is transferred from one school to another school in the same or any other district there may be paid to him such travelling-expenses in excess of £1 incurred by him in respect of his appointment or transfer as are considered by the Director to be reasonable in the circumstances.”

PART III.—TRAINING-COLLEGES.

21. (1) Clause 11 (3A) of the regulations relating to training-colleges (as prescribed by clause 4 of the Training College Regulations 1926, Amendment No. 17)* is hereby amended by omitting the symbols and figures “£209 15s.”, and substituting the symbols and figures “£230 8s. 1d.”.

(2) This clause shall be deemed to have come into force on the 1st day of October, 1940.

PART IV.—ORGANIZATION AND MANAGEMENT OF PUBLIC SCHOOLS.

22. The regulations relating to the organization, examination, and inspection of public schools made under the Education Act, 1914, on the 14th day of October, 1929, and published in the *Gazette* of that year at page 2647, are hereby amended by revoking clause 7 thereof, and substituting the following clause :—

“7. (1) Every public school shall be visited by an Inspector of Schools at least once in every period of two years. No notice of any visit need be given unless the Inspector deems it advisable to hold a detailed survey of the work of the pupils, in which case he shall give or cause to be given to the Head Teacher at least ten days' notice of

his intention to visit the school. After one of his visits in every period of two years the Inspector shall present to the Education Board an inspection report, but a special report may be presented after any visit.

“(2) The inspection report shall contain a statement in general terms regarding the conduct and efficiency of the school and other matters which in the opinion of the Inspector should be brought under the notice of the Education Board and the School Committee.

“(3) There shall be three copies of the inspection report on the form provided for the purpose by the Department, which shall be dealt with as follows :—

“(a) One copy shall be filed by the Senior Inspector for the use of the Education Department :

“(b) Two copies shall be submitted to the Education Board, of which one shall be kept by the Board and one shall be sent by the Board to the Head Teacher, by whom it shall be filed in the school records.

“(4) No part of any report by an Inspector of Schools shall be published.

“(5) An Inspector of Schools, after consultation with the Head Teacher, may alter for such period as he considers necessary the organization of a school, the schemes of work, or the classification of the pupils.”

PART V.—SCHOOL CERTIFICATE EXAMINATION.

23. The School Certificate Examination Regulations 1934, made under the Education Act, 1914, by Order in Council dated the 20th day of March, 1934, and published in the *Gazette* of the 5th day of April following,* are hereby amended as follows :—

(a) By adding to the list of subjects in clause 7 thereof the following subject : “ 32. Practical Mathematics ”.

(b) By adding to clause 14 thereof a definition of the scope of the subject “ Practical Mathematics ”, as follows :—

(32) PRACTICAL MATHEMATICS.

(TWO TWO-HOUR PAPERS.)

The plotting of graphs from given numerical data and reading interpolations from graphs so plotted ; interpretation of the slope of graphs ; the application of graphs to practical problems. Rate of increase. Maxima and minima.

Areas of regular figures, including ellipses and segments of circles ; areas of irregular figures ; mid-ordinates.

Volumes of regular figures, including frusta, spherical zones, and spherical segments. Simpson's rule.

Evaluation and transformation of formulæ and the construction of formulæ from given data.

Factors of simple types and fractions based on them.

Solution of equations, including quadratic equations involving one unknown quantity ; graphical methods of solution ; practical problems involving equations.

Powers, roots, and logarithms ; slide rule.

Ratio, proportion, and variation. Arithmetical and geometrical progression.

Angular measurement in degrees and radians ; circular measure.

Graphs of sines and cosines of angles from 0° to 180° .

Ideas of symmetry and superposition. Congruence of triangles.

Parallels, parallelograms, and rectangles. Theorem of Pythagoras and its applications.

Similar figures ; proportional division ; diagonal scale.

Trigonometrical ratios ; solution of triangles, excluding ambiguous case. (Proofs of formulæ not required.)

The circle ; chord and centre : relations of arcs, angles, and chords ; tangents and common tangents ; cyclic quadrilaterals ; circumscribed, inscribed, and escribed circles of a triangle.

Inscription in or circumscription to a given circle of regular figures of 3, 4, 6, or 8 sides.

Vectors ; resultant of vectors ; resolution of vectors.

Planes ; angles between lines and planes and between two planes ; lines of greatest slope in a plane ; projections.

N.B.—(1) In any problem involving calculations metric units may be used instead of British units.

(2) No formal proofs of geometrical theorems will be required ; the use of slide rules in calculations will be permitted in the examination room.
