# THE EDUCATION AMENDING REGULATIONS 1942 (NO. 2)

C. L. N. NEWALL, Governor-General. ORDER IN COUNCIL.

At the Government House at Wellington, this 23rd day of December, 1942.

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to the Education Act, 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

## **REGULATIONS.**

1. (1) These regulations may be cited as the Education Amending Regulations 1942 (No. 2).

(2) Except as otherwise provided herein, these regulations shall come into force on the day following the date of publication in the *Gazette* of a notification of the making thereof.\*

#### BIENNIAL GRADING OF TEACHERS IN SECONDARY SCHOOLS.

2. (1) Notwithstanding anything to the contrary in the regulations as to secondary schools, made by Order in Council dated the 5th day of May, 1924, and published in the *Gazette* of the 8th day of the same month<sup>†</sup>, there shall be no general grading of teachers in accordance with those regulations in the year 1942, and the first general grading of such teachers after the coming into force of these regulations shall be made in the month of December, 1943.

(2) Thereafter the general grading of teachers in accordance with the said regulations shall be made in every alternate year, and not annually.

(3) Nothing in this clause shall prevent the grading at any time of a teacher who has not theretofore been graded, or the regrading at any time of any teacher if, in the special circumstances of the case, the Director, on the recommendation of the Chief Inspector of Secondary Schools, is of opinion that the teacher should be regraded.

3. (1) In special cases the Director, on the recommendation of the Chief Inspector of Secondary Schools, may, in accordance with the following provisions of this clause, approve of the grant of an increment to the salary of any full-time assistant in a secondary school who is for the time being classified in Grade C or Grade D in accordance with the regulations referred to in the last preceding clause.

(2) Any increment granted under this clause shall be of an amount sufficient to increase the rate of the salary of the assistant to whom it is granted to the minimum rate prescribed for the next highest grade.

(3) No increment the grant of which is approved by the Director pursuant to this clause shall take effect at any time before the assistant has been in receipt of the maximum rate of salary prescribed for his grade for at least twelve months.

(4) Subject to the last preceding subclause, any increment approved by the Director pursuant to this clause shall take effect on the 1st day of February of the year in which the approval is granted.

#### GRADING OF PRIMARY-SCHOOL TEACHERS FOR YEARS 1943 AND 1944.

4. (1) Notwithstanding anything in the regulations relating to the grading of primary-school teachers made under the Education Act, 1914, by Order in Council dated the 30th day of March, 1926,\* the general grading to be made pursuant to those regulations in the year 1943 shall be made for the years 1943 and 1944, and no general grading shall be made in the year 1944.

(2) In the grading made in the year 1943 marks shall be assigned to cover both years, and the aggregate marks assigned to any teacher for efficiency shall be allotted in accordance with the following provisions, namely :---

- (a) In the absence of special circumstances, one-half of the aggregate marks so assigned shall be allotted as at the 1st January, 1943, and the residue of the marks shall be allotted as at the 1st January, 1944. For the purposes of this paragraph, if the aggregate marks so assigned is not an even number, the number of marks allotted as at 1st January, 1943, shall be one-half of the next highest even number:
- (b) In special circumstances, and for the purpose of avoiding anomalies or hardship, the Director may, in his discretion, allot the aggregate marks so assigned to any teacher as follows :-

(i) All the marks so assigned to the teacher may be allotted as at the 1st day of January, 1943; or

(ii) Any number or proportion of those marks may be allotted as at the 1st day of January, 1943, and the residue shall be allotted as at the 1st day of January, 1944.

(3) Notwithstanding anything in clause 18 of the regulations hereinbefore referred to, it shall not be necessary to publish a general graded list of teachers for the year 1943 or the year 1944.

#### Amending Regulations as to Teachers' Salaries.

5. (1) In this clause the expression "the said regulations" means the Teachers' Salaries Regulations 1938<sup>†</sup>.

(2) Clauses 19 and 99 and subclause (3) of clause 104 of the said regulations (as severally amended by clause 9 of the Education Amending Regulations 1941<sup>‡</sup>) are hereby further amended by omitting the several references therein to "£230 8s. 1d.", and substituting in each case a reference to "£243".

(3) Clause 48 of the said regulations is hereby amended by inserting, after the word "hereof" in subclause (2), the words "or such higher rate of salary within the appropriate grade as may be approved by the Public Service Commissioner".

(4) Clause 9 of the Education Amending Regulations 1941\* is hereby consequentially revoked.

(5) This clause shall be deemed to have come into force on the 1st day of September, 1942.

#### Amending Regulations as to Training Colleges.

6. (1) Clause 11 (3A) of the regulations relating to training colleges (as prescribed by clause 4 of the Training College Regulations 1926, Amendment No. 17<sup>†</sup>, and amended by clause 21 of the Education Amending Regulations 1941\*) is hereby further amended by omitting the reference to "£230 8s. 1d.", and substituting a reference to "£243".

(2) Clause 21 of the Education Amending Regulations 1941\* is hereby consequentially revoked.

(3) This clause shall be deemed to have come into force on the 1st day of September, 1942.

## AMENDING REGULATIONS AS TO INCIDENTAL EXPENSES OF SCHOOL COMMITTEES.

7. (1) The regulations relating to the incidental expenses of School Committees (made under the Education Act, 1914, by Order in Council dated the 11th day of October, 1920<sup>‡</sup>), as heretofore from time to time amended, are hereby further amended by adding to the regulation distinguished by the capital letter B the following new paragraph :---

"(h) The cost of purchasing or hiring any educational apparatus or equipment or any other material approved by the Minister for the use of any school, and the cost of maintaining any such apparatus or equipment."

(2) Any approval given by the Minister for the purposes of this clause may be of general application to all schools, or may be given in respect of a specified school or of schools of a specified class.

#### Amending Regulations as to the School Certificate EXAMINATION.

8. (1) The School Certificate Examination Regulations 1934§, are hereby amended by inserting, after clause 6 thereof, the following new clause :--

"6A. (1) Notwithstanding anything to the contrary in these regulations, a candidate for the School Certificate Examination who has complied with the requirements of clauses 4 and 5 hereof, but who, by reason of personal illness or accident, is unable to sit for the examination or for any of the subjects of examination for which he has entered, may qualify for and be granted a School Certificate in accordance with the special provisions of this clause.

"(2) A School Certificate shall not in any case be granted under this clause unless-

"(a) Notice of the inability of the candidate to sit for the examination or for any of the subjects thereof has been given to the Director of Education as soon as possible after it became known that he would be unable to sit for the examination; and

"(b) Application for the grant of a School Certificate, signed by the candidate or by some person on his behalf, has been made to the Director not later than the 31st day of December of the year in which the examination has been held.

"(3) The notice of a candidate's inability to sit for the examination shall be supported by such evidence as the Director may in any case require (including a medical certificate in every case, unless the production of such a certificate is in any case dispensed with by the Director).

"(4) Every application for the grant of a School Certificate under this clause shall be supported by—

- "(a) A certificate signed by the Headmaster or Principal of the school to the effect that the candidate was in actual attendance at the school for the whole or for part of the third term of the school year, and that in the definite opinion of the Headmaster or Principal the candidate would have passed in all the subjects for which he had entered and for which he was unable to sit, or, in the case of a candidate who entered for more than the required number of subjects, that he would have passed in the compulsory subject and in the required number of optional subjects :
- "(b) A copy (to be furnished by the Headmaster or Principal) of the appropriate school records for the year, showing the candidate's marks in the periodical school examinations in the subject or subjects for which he was unable to sit for examination, and his position in class with regard to those subjects, or his position relative to other candidates from the same school.

"(5) A School Certificate granted pursuant to this clause may be distinguished from other such certificates in such manner (if any) as the Director thinks fit".

## Amending Regulations as to Kindergarten Grants.

9. Clause 6 of the Kindergarten Grants Regulations  $1937^*$  (by which is prescribed a new Regulation 3 of certain regulations relating to grants in aid of free kindergarten schools) is hereby amended by omitting from the said Regulation 3 the reference to "£1 6s. 8d.", and substituting a reference to "£1 13s. 4d.".
