THE EDUCATION AMENDING REGULATIONS 1945

At the Government House at Wellington, this 23rd day of May, 1945

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Education Act, 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

- 1. (1) These regulations may be cited as the Education Amending Regulations 1945.
- (2) Except as otherwise provided therein, these regulations shall be deemed to have come into force on the 31st day of March, 1945.

PART I

TEACHERS' SALARIES

- 2. This Part of these regulations shall be read together with and deemed part of the Teachers' Salaries Regulations 1938* (hereinafter in this Part referred to as the principal regulations).
- 3. Clause 19 of the principal regulations is hereby revoked, and the following clause is hereby substituted therefor:—
- "19. (1) Except as provided in the next succeeding subclause, the salary of a probationary assistant employed in any school shall be at the rate of £155 per annum.
- "(2) With the approval of the Minister, a salary at the rate of £243 per annum may be granted to any married probationary assistant who, if he or she were a certificated teacher, would be entitled to a 'married' salary under clause 18 hereof."
- 4. (1) The principal regulations are hereby further amended by inserting, after clause 44, the following new clause:—

"44A. (1) The Board, with the approval of the Director, may

appoint an additional assistant to any position in any school:

"Provided that, except in the case of an additional assistant appointed as teacher of Form III in a mixed school, no additional assistant shall be appointed under this clause except on the recommendation of the Senior Inspector.

- "(2) An additional assistant appointed under this clause shall be entitled to such basic salary and to such position salary (if any) as may be determined by the Director.
- "(3) The authority conferred by this clause shall not be subject to the provisions of clause 44 hereof."
- (2) Clause 44 of the principal regulations is hereby consequentially amended by revoking subclause (6) thereof.
- 5. (1) The definition of the term "normal school" in clause 4 of the principal regulations is hereby amended by inserting, after the words "organized as a mixed school or as a contributing school", the words "or as an intermediate school".
- (2) The said regulations are hereby further amended by inserting, after clause 74, the following new clause:—

"74a. Provision for Normal School organized as an Intermediate School

- "(1) The provisions of clause 73 hereof shall not apply with respect to any normal school that is for the time being organized as an intermediate school.
- "(2) With respect to any such normal school the following special provisions shall apply:—
 - "(a) The grade of basic and position salary payable to the headmaster shall be A33:
 - "(b) The grades of basic and position salaries payable to the assistants on the staff of the school and the number of assistants of each grade shall be as follows:—

- "(c) In addition to the number of assistants provided for in the last preceding paragraph there shall be such number of Grade A3 assistants as may be necessary to provide that on the staff of the school there shall be one assistant teacher for every 35 pupils on the roll of the school on the 1st day of March in any year.
- "(d) The proportion of male and female assistants shall be the same as for an intermediate school with the same number of teachers.
- "(3) If an assistant teacher on the staff of a normal school to which this clause applies is required to lecture to students for at least twenty periods in any year, the rate of his salary for that year shall be increased by £10."
- 6. (1) Part II and Part III of the Education (Post-primary Teachers) Regulations 1945* shall, with the necessary modifications, apply with respect to the assistant teachers for the time being engaged on the staff of the secondary department of the Correspondence School as if the Correspondence School were a school to which those regulations apply.

- (2) Clauses 87 and 89 of the principal regulations are hereby consequentially revoked.
- (3) This regulation, in so far as it relates to the salaries and allowances payable to assistant teachers on the staff of the secondary department of the Correspondence School, shall be deemed to have come into force on the 1st day of February, 1944.
- 7. (1) The Public Service Commissioner shall from time to time determine the number of Grade V positions in the secondary department of the Correspondence School.
- (2) Regulation 32 of the Education (Post-primary Teachers) Regulations 1945* shall, with any necessary modifications, apply with respect to the secondary department of the Correspondence School.
- (3) Clause 88 of the principal regulations is hereby consequentially revoked.

PART II.—MISCELLANEOUS PROVISIONS

TRAINING COLLEGES

- 8. (1) Subclause (3) of clause 11 of the regulations as to training colleges (as the said subclause is set out in the Training College Regulations 1926, Amendment No. 14†) is hereby amended by omitting the words "thirty pounds", and substituting the words "forty pounds".
- (2) This regulation shall be deemed to have come into force on the 1st day of September, 1944.
- 9. (1) In addition to the allowances otherwise payable to training-college students, there may, with the approval of the Minister, be paid to any married student who, if he or she were a certificated teacher on the staff of a public school, would be entitled to a "married" salary under the Teachers' Salaries Regulations 1938 an annual allowance equal to the difference between £243 and the annual allowances payable to the student under subclauses (2) and (3) of clause 11 of the regulations relating to training colleges made under the Education Act, 1914, by Order in Council dated the 13th day of December, 1926 (as the said regulations have from time to time been amended).
- (2) Clause 4 of the Training College Regulations 1926, Amendment No. 17[‡], and clause 6 of the Education Amending Regulations 1942 (No. 2)§ are hereby consequentially revoked.

MANUAL AND TECHNICAL STUDENT TEACHERS

- 10. (1) Clause 57 of the regulations relating to manual and technical instruction (as the said clause is set out in clause 11 of the Manual and Technical Instruction Regulations 1925, Amendment No. 14||) is hereby amended by omitting from subclause (ii) the reference to "£30 per annum", and substituting a reference to "£40 per annum".
- (2) This regulation shall be deemed to have come into force on the 1st day of September, 1944.

GRADING OF PRIMARY-SCHOOL TEACHERS FOR YEARS 1945 AND 1946

- 11. (1) Notwithstanding anything in the regulations relating to the grading of primary-school teachers made under the Education Act, 1914, by Order in Council dated the 30th day of March, 1926,* the general grading to be made pursuant to those regulations in the year 1945 shall be made for the years 1945 and 1946, and no general grading shall be made in the year 1946.
- (2) In the grading made in the year 1945 marks shall be assigned to cover both years, and the aggregate marks assigned to any teacher for efficiency shall be allotted in accordance with the following provisons, namely:
 - (a) In the absence of special circumstances, one-half of the aggregate marks so assigned shall be allotted as at the 1st day of January, 1945, and the residue of the marks shall be allotted as at the 1st day of January, 1946. For the purposes of this paragraph, if the aggregate marks so assigned is not an even number, the number of marks allotted as at the 1st day of January, 1945, shall be one-half of the next highest number:
 - (b) In special circumstances, and for the purpose of avoiding anomalies or hardship, the Director may, in his discretion, allot the aggregate marks so assigned to any teacher as

(i) All the marks so assigned to the teacher may be

- allotted as at the 1st day of January, 1945; or
 (ii) Any number or proportion of those marks may be allotted as at the 1st day of January, 1945, and the residue shall be allotted as at the 1st day of January, 1946.
- (3) Notwithstanding anything in clause 18 of the regulations hereinbefore referred to, it shall not be necessary to publish a general graded list of teachers for the year 1945 or the year 1946.
