# THE EDUCATION (SALARIES AND STAFFING) REGULATIONS 1948, AMENDMENT NO. 2

# FREYBERG, Governor-General ORDER IN COUNCIL

At the Government Buildings at Wellington, this 10th day of March 1952

#### Present:

THE RIGHT HON. S. G. HOLLAND PRESIDING IN COUNCIL

PURSUANT to the Education Act 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

1. These regulations may be cited as the Education (Salaries and Staffing) Regulations 1948, Amendment No. 2, and shall be read together with and deemed part of the Education (Salaries and Staffing) Regulations 1948\* (hereinafter referred to as the principal regulations).

2. Regulation 58 of the principal regulations is hereby amended by

adding the following proviso:-

"Provided that, in making an appointment to the position of a teacher in a Maori school, preference may be given to an applicant if the husband or wife of the applicant, being a certificated teacher, is an applicant for or holds a position as a teacher in that school and if in the opinion of the Director it is desirable in the interests of the school that a man and his wife should be appointed."

3. The principal regulations are hereby amended by inserting, after

regulation 94, the following regulation:

"94A. (1) An Education Board may, on the recommendation of the Senior Inspector, conduct classes outside normal school hours in music and art and any other subject approved by the Director for the purposes of this regulation.

- "(2) Every such class shall require the approval of the Director, whose approval may be given for a limited period and may in any case be withdrawn. No class shall be approved under this regulation unless in the opinion of the Director there are sufficient pupils enrolled or likely to be enrolled to justify the appointment of a part-time teacher.
- "(3) Teachers appointed to any such classes shall be paid salary as for a part-time teacher in a post-primary school under regulation 115 hereof, the rate not to exceed the rate of capitation payable under that regulation."

4. The principal regulations are hereby amended by inserting, after

regulation 142, the following regulation:

"142A. When a teacher who is paid 'married' salary under regulation 18 hereof takes up his first permanent appointment, he shall be entitled to the payment, in accordance with the foregoing provisions of this Part of these regulations, of—

"(a) Half of the cost of the conveyance of the teacher's household furniture and effects to his new position, but not

exceeding £40 in any case; and

- "(b) Half of the cost of the conveyance of the teacher and his family (if any) to his new position."
- 5. Regulation 154 of the principal regulations, as added by regulation 22 of the Education (Salaries and Staffing) Regulations 1948, Amendment No. 1, is hereby amended by adding the following subclause:—
- "(5) The rate of any salaries which were payable under these regulations at a rate in excess of £1,080 a year on the 15th day of February 1951 is hereby further increased on and after that date by £141 15s. a year."
- 6. The Second Schedule to the principal regulations is hereby amended as from the 1st day of November 1951—
  - (a) By omitting from the line relating to schools of Grade IVc the figure "1" where it appears in the column numbered (5) under the heading "B":
  - (b) By inserting the figure "1" in the said line under the heading "B" in the column numbered (4).
- 7. The Third Schedule to the principal regulations, as substituted by the First Schedule to the Education (Salaries and Staffing) Regulations 1948, Amendment No. 1, is hereby amended as from the 1st day of November 1951—
  - (a) By omitting from the line relating to schools of Grade IVc the figure "1" where it occurs in the column numbered (4):
  - (b) By inserting the figure "1" in the said line under the heading "Assistant Master, Grade B" in the said column.
- 8. The Fourth Schedule to the principal regulations, as substituted by the Second Schedule to the Education (Salaries and Staffing) Regulations 1948, Amendment No. 1, is hereby amended as from the 1st day of November 1951—
  - (a) By omitting from the line relating to schools of Grade IVc the figure "1" where it occurs in the column numbered (5) under the heading "B":
  - (b) By inserting the figure "1" in the said line under the heading "B" in the column numbered (4).

9. The Fifth Schedule to the principal regulations, as substituted by the Third Schedule to the Education (Salaries and Staffing) Regulations 1948, Amendment No. 1, is hereby amended as from the 1st day of November 1951—

(a) By omitting from the line relating to schools of Grade IVc the figure "1" where it occurs in the column numbered (4):

- (b) By inserting the figure "1" in the said line under the heading "Assistant Master, Grade B" in the said column.
- 10. The Seventh Schedule to the principal regulations is hereby amended as from the 1st day of November 1951-

(a) By omitting from the line relating to schools of Grade IVc the figure "1" where it appears in the column numbered (5)

under the heading "B":
(b) By inserting the figure "1" in the said line under heading "B"

in the column numbered (4).

- 11. The Eighth Schedule to the principal regulations, as substituted by the Fourth Schedule to the Education (Salaries and Staffing) Regulations 1948, Amendment No. 1, is hereby amended as from the 1st day of November 1951-
  - (a) By omitting from the line relating to schools of Grade IVc the figure "I" where it occurs in the column numbered (4):
  - (b) By inserting the figure "1" in the said line under the heading "Assistant Master, Grade B" in the said column.

#### EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

1. Regulation 2 provides that an applicant for appointment to a position in a Maori school may be given preference over other applicants if the husband or wife of the applicant, being a certificated teacher, is an applicant for or holds a position in the school and if the Director is of the opinion that it is desirable in the interests of the school that a man and his wife should be appointed.

2. Regulation 3 gives authority for classes in music, art, and other approved subjects to be conducted outside normal school hours with the approval of the Director, and specifies the salaries payable to teachers who conduct any such

3. Regulation 4 prescribes the removal expenses which may be paid to a teacher who is entitled to "married" salary when the teacher takes up his first

4. Regulation 5 is consequential on the 15 per cent wage increase and relates to teachers whose salaries cannot be adjusted by the Government Service Tribunal because they are in excess of £1,080 a year. The regulation provides for them to receive an increase in salary at the rate of £141 15s. a year on and after 15 February 1951 in addition to the £18 5s. a year which became payable to them on and after 8 May 1950.

5. Regulations 6 to 11 provide that mixed schools and Maori schools of

Grade IVc are to have an assistant master of Grade B instead of an assistant

mistress of that grade.
