THE EDUCATION (SALARIES AND STAFFING) REGULATIONS 1957, AMENDMENT NO. 19

ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Education (Salaries and Staffing) Regulations 1957, Amendment No. 19, and shall be read together with and deemed part of the Education (Salaries and Staffing) Regulations 1957* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 2nd day of February 1981.
- 2. Determination of staffing entitlement—Regulation 30 of the principal regulations (as substituted by regulation 6 of the Education (Salaries and Staffing) Regulations 1957, Amendment No. 18) is hereby amended—
 - (a) By omitting from subclause (5) the expression "155" in both places where it occurs, and substituting in each case the expression "150":

- (b) By omitting from subclause (6) and also from subclause (7), the expression "156", and substituting in each case the expression "151".
- 3. Additional teaching position in certain cases where school roll falls—Regulation 31 of the principal regulations (as substituted by regulation 5 of the Education (Staffing and Salaries) Regulations 1957, Amendment No. 14) is hereby amended by adding the following paragraph:
 - "(h) Where any school that has a basic staffing entitlement of 8 or more teachers has its basic staffing entitlement reduced to less than 8 teachers as a result of a fall in the roll of the school, the school shall be entitled to 1 additional teaching position to release the principal from classroom teaching while he is on the National Transfer List."
- 4. Preservation of position and grading of certain principals—Notwithstanding anything in the Education (Assessment, Classification, and Appointment) Regulations 1976, where, immediately before the commencement of these regulations, any person held or had received a letter of appointment to the position of principal of a school that has a roll of less than 156, that person may retain his position so long as the position of principal of that school retains the same grading as determined under regulation 35 of the principal regulations in respect of the 1981 school year.
- 5. Schedules—The principal regulations are hereby amended by revoking the Fourteenth and Fifteenth Schedules (as added by regulation 11 (1) (c) of the Education (Salaries and Staffing) Regulations 1957, Amendment No. 18), and substituting the Fourteenth and Fifteenth Schedules set out in the Schedule to these regulations.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 2 February 1981, amend the Education (Salaries and Staffing) Regulations 1957.

A staff-pupil ratio of 1:25 is established for full primary schools and contri-

buting schools having rolls that do not exceed 150 pupils.

Provision is made for the appointment of an additional teacher to release a principal from classroom teaching where the principal is on the National Transfer List as a result of the roll of the school having fallen.

Provision is also made for the preservation of the position and grading of the principal of any school with a roll of less than 156 so long as the grading of the position of principal of that school remains the same as for the 1981 school year.
