

## THE EDUCATION (SALARIES AND STAFFING) REGULATIONS **1957, AMENDMENT NO. 26**

### ORDER IN COUNCIL

At Wellington this 21st day of July 1986

#### Present:

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL PURSUANT to the Education Act 1964, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Education (Salaries and Staffing) Regulations 1957, Amendment No. 26, and shall be read together with and deemed part of the Education (Salaries and Staffing) Regulations 1957\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 15th day of August 1986.
- 2. New Schedules substituted—(1) The principal regulations are hereby amended by revoking the Third Schedule (as substituted by regulation 11

- (1) (a) of the Education (Salaries and Staffing) Regulations 1957, Amendment No. 18), and substituting the schedule set out in the First Schedule to these regulations.
- (2) The principal regulations are hereby amended by revoking the Fifth Schedule (as substituted by regulation 6 (1) of the Education (Salaries and Staffing) Regulations 1957, Amendment No. 21), and substituting the schedule set out in the Second Schedule to these regulations.
  - (3) The following provisions are hereby consequentially revoked:
  - (a) Regulation 11 (1) (a) of the Education (Salaries and Staffing) Regulations 1957, Amendment No. 18:
  - (b) Regulation 6 of the Education (Salaries and Staffing) Regulations 1957, Amendment No. 21.
