# THE EDUCATION (SALARIES AND STAFFING) REGULATIONS 1957, AMENDMENT NO. 28

#### ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Education (Salaries and Staffing) Regulations 1957, Amendment No. 28, and shall be read together with and deemed part of the Education (Salaries and Staffing) Regulations 1957\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 14th day after the date of their notification in the Gazette.
- 2. Relieving teachers—Regulation 36 of the principal regulations (as substituted by regulation 2 of the Education (Salaries and Staffing)

Regulations 1957, Amendment No. 15) is hereby amended by revoking subclause (2), and substituting the following subclauses:

- "(1A) For the purposes of subclause (1) of this regulation, where one of 2 teachers who jointly have been permanently appointed to a full-time position is temporarily absent that position is, to that extent only, a fulltime position that has temporarily become vacant.
- "(2) No relieving teacher shall be appointed for a period of less than one day except—
  - "(a) With the approval of the Director-General; or
  - "(b) In respect of the absence of one of 2 teachers who have jointly been permanently appointed to a full-time position."
- 3. Relieving teachers in secondary schools—(1) Regulation 57 of the principal regulations is hereby amended by revoking subclause (2) (as substituted by regulation 4 (3) of the Education (Salaries and Staffing) Regulations 1957, Amendment No. 27), and substituting the following subclause:
- "(2) No relieving teacher shall be appointed for a period of less than one day, except-
  - (a) With the approval of the Director General; or
  - "(b) In respect of a permanent part-time position."
- (2) Regulation 4 (3) of the Education (Salaries and Staffing) Regulations 1957, Amendment No. 27 is hereby consequentially revoked.

## EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Education (Salaries and Staffing) Regulations 1957 so as to enable the appointment of a relieving teacher in respect of any temporary vacancy in a position held by 2 permanently appointed part-time teachers.
