HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Education (Salaries and Staffing) Regulations 1957, Amendment No. 29, and shall be read together with and deemed part of the Education (Salaries and Staffing) Regulations 1957* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 28th day after the date of their notification in the Gazette.

- 2. Positions of responsibility—Regulation 35 of the principal regulations (as substituted by regulation 5 of the Education (Salaries and Staffing) Regulations 1957, Amendment No. 21, and amended by regulation 6 of the Education (Salaries and Staffing) Regulations 1957, Amendment No. 22) is hereby further amended by adding the following subclauses:
 - "(4) Notwithstanding subclauses (1) and (2) of this regulation, where—
 - "(a) Any school is entitled by those subclauses to a position of Senior Teacher; and
 - "(b) The position is vacant; and
 - "(c) The school's principal so recommends to the Education Board; and
 - "(d) The Education Board so resolves,—
- the position may be advertised as a basic scale position and filled accordingly.
 - "(5) Where—
 - "(a) Any school is entitled by subclauses (1) and (2) of these regulations to a position of Senior Teacher; and
 - "(b) By virtue of the appointment of a basic scale teacher under subclause (4) of this regulation, the school has no senior teacher; and
- "(c) Any basic scale position at the school (including the position to which the appointment was made) becomes vacant,—
 these regulations shall apply to the vacant position as if it is a position of Senior Teacher."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 28 days after notification in the Gazette, allow an Education Board, on the recommendation of a school's principal, to fill a vacant Senior Teacher position at the school with a basic scale teacher.
