# THE EDUCATION BOARDS ADMINISTRATION REGULATIONS 1965, AMENDMENT NO. 2

#### ORDER IN COUNCIL

Pursuant to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Education Boards Administration Regulations 1965, Amendment No. 2, and shall be read together with and deemed part of the Education Boards Administration Regulations 1965 (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force simultaneously with

section 3 of the Education Amendment Act (No. 2) 1974.

2. Division of regulations in Parts—Regulation 1 (3) of the principal regulations is hereby amended by inserting, after the expression "Part III—Election of members of Education Boards", the expression "Part IIIA—Appointment of member to represent all teachers".

3. Teacher representatives—The principal regulations are hereby amended by inserting, after Part III, the following part:

"PART IIIA—APPOINTMENT OF MEMBERS TO REPRESENT ALL TEACHERS "34A. The member to represent all teachers employed by the Board (in this part of these regulations referred to as the teacher representative) shall be appointed by the Board on the nomination of the National Executive of the New Zealand Educational Institute.

"34B. Every person, male or female, who has attained the age of 18 years and is not disqualified as mentioned in section 18 of the Act,

shall be qualified to become a teacher representative."

"34c. The first teacher representative appointed to a Board shall hold office until the next date for election of members of that Board pursuant to regulation 9 (1) (a) of these regulations.

"34p. Every subsequent teacher representative shall be appointed for a term of 2 years, taking office on the second Wednesday in August.

"34e. A teacher representative shall be eligible for reappointment."

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force upon the commencement of section 3 of the Education Amendment Act (No. 2) 1974, add to the principal regulations a new part dealing with teacher representatives, whose appointment to Education Boards that section authorises. Teacher representatives are to be appointed by the Board on the nomination of the Executive of the New Zealand Educational Institute. Initial appointees will serve until the next Board election. Other appointees will serve the normal 2 year term.
